A fantastic watch

In 1978 you will be able to wear – if you so desire – a really fantastic watch. It has just been demonstrated in Geneva by a watch factory which is a branch of a family concern in La Chaux-de-Fonds, founded in 1875.



What has so far only been a remote dream has now become reality. Be your own judge. A whole row of electronic instruments have been built into a synthetic case measuring no more than 5.5x6 cm. When one wants the most accurate time, one finds hours, minutes, seconds, month and day, all showing up according to the LCD system, i.e. with the help of liquid crystals. In the same case, there are devices which show your pulse rhythm and your body temperature. Furthermore, there is a miniature calculator which enables one to carry out the four basic arithmetic operations. You can easily check bills in shops and restaurants and it will help you when changing money. You simply touch the keys of the calculator with the tip of a pencil. Yet that is not all. A miniature radio without loudspeaker but with headphones allows you to listen to the programme of your choice.

Finally, and this is unique, the case contains a television receiver. The diameter of the screen is 2.5 cm, yet the picture is transmitted extremely clearly. The first models will be able to receive one programme only . . . in black-and-white. The TV sound may be heard on the headphones. There is no doubt that time will pass much more quickly with such a «watch»!
