## Hockey

### Why not play in Switzerland?

Swiss heritage has brought financial rewards for many American and Canadian young men.

Having learned to play ice hockey in North America, young players have brought their talents back to the land of their fathers. In return, many of these players are now members of the Swiss National Hockey Team, which participates yearly in the World Hockey Championships and in 1992, the Winter Olympic Games.

Although there are some 40 dual citizen players in Switzerland, only a few have made their mark by earning positions on the National Team: Misko Antisin and Keith Fair of British Columbia, Rick Tschumi of Toronto, Ontario, and Doug Honegger of Montreal, Quebec.

### High Caliber League Play

The Swiss National A League (NLA) has been the most competitive hockey league in the world during the 1992-93 season. At one time there were only four points separating the top eight teams in the ten team league. The high caliber of play and the standard of living in Switzerland have made the Swiss NLA the "place to be" if you are not in the *National Hockey League* of North America. Indeed, the Swiss NLA is often called the NHL of Europe. It combines the best play, arenas, salaries and living

conditions with great fan enthusiasm and support.

### Young Start

Back to our four heroes...both Keith Fair and Doug Honegger started their Swiss careers early in life, playing with Ambri-Piotta at the age of 17. Today, Fair has remained in Ambri, while Honegger has moved down the autostrada to Lugano. Rick Tschumi started also as a teenager in Ambri and after ten years there, he is now the team captain and elder statesman in Ambri hockey. Misko Antisin completed his junior hockey career in Victoria, BC, before moving to the Swiss League with Zürich (ZSC). In his seventh season, Misko now plays with EV Zug.

### More to Come

All but two of the dual citizen players in the NLA arrived in Switzerland through International Sports Management Limited of Montreal, Canada. Danny McCann, ISM's president, has been sending players from North America to European countries for over 20 years.

## Perceptions of Switzerland

For over seven years, Swiss people in many countries have been enthusiastically buying *History of Switzerland*, written by J. Murray Luck, and published by a small scholarly organization in Palo Alto, California. A comprehensive book on Switzerland's past and present, it provides a chronological account of Swiss history through the end of the 19th century, as well as topical chapters on 20th century developments. Indeed, the *Schweizerische Zeitschrift für Geschichte* has declared that "this book...will for many years most likely remain the standard work on Swiss history for the English-speaking world."

It was Murray Luck's appointment as Science Attaché at the American Embassy in Switzerland, that led to his fascination with the country. And this fascination did not lead to a biased perception of his subject: as a reviewer in the *Swiss American Historical Society Newsletter* has noted, "As an outsider with very sharp eyes, Luck sees us as we really are, whereas we Swiss often either

glorify or vituperate our past."

Such praise is always very cheering for author and publisher alike, especially for small publishers like SPOSS, the organization that launched *History of Switzerland*. Known more formally as the Society for the Promotion of Science and Scholarship, SPOSS was established in 1976 by Murray Luck in order to assist young academics in their careers by publishing their work of excellent scholarly quality, often rejected simply on economic grounds by larger publishing houses. Since its inception, SPOSS has published various books on the history and culture of Switzerland, Austria, Belgium, France, and England.

## Swiss Home in Mount Kisco Ceases Operations

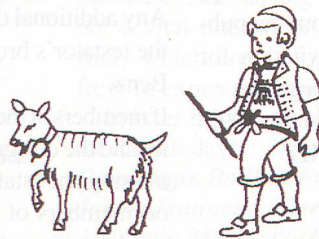
The Boards of Directors of the Swiss Home, Inc. and its sponsoring organization, the Swiss Benevolent Society of New York, have announced the closing of the Swiss Home in Mount Kisco. This drastic step is mandated by unavoidable operating deficits, which have exhausted both non-profit organizations' financial resources, and an inadequate building, which no longer meets the State of New York's requirements for a nursing home. The residents of the home will be appropriately placed in other area facilities.

The Swiss Benevolent Society has been subsidizing the Swiss Home at an annual rate of \$200,000.

It was hoped that the Swiss Home could remain open until a replacement facility would be operational on adjacent property belonging to the Swiss Benevolent Society. However, the necessary approvals from the community have been delayed and the financial reserves of both Swiss organizations drained, making it impossible to keep the Swiss Home going.

The Swiss Benevolent Society will continue to care for elderly compatriots through its Social Service program. The Swiss community will continue to use the Swiss Home buildings and the surrounding grounds for Swiss National Day celebrations and other events.
