## Support for dedicated parents

**Questions of education and training have high priority with the Swiss Abroad. The Secretariat for the Swiss Abroad (SSA) and a federal law can provide extra help.**

Education is one of the most important components in the SSA's range of services. Two of its associated institutions deal with it exclusively: the Committee for Swiss Schools Abroad and AJAS (see box). The latter receives a federal subsidy on the basis of the

Swiss Abroad Training Law of October 9, 1987.

The Law aims to "strengthen the ties of young Swiss Abroad with the homeland, facilitate entry into schools and vocational training in Switzerland and at the same time promote Switzer-

land's cultural presence abroad within this context".

It works mainly in two areas:

- Swiss schools abroad (see Swiss Review 5/94);
- Education outside Swiss schools.

The second of these includes providing advice for young Swiss Abroad wishing to complete their education in Switzerland and supporting Swiss communities dedicated to the education of Swiss children abroad. In particular, Article 10 of the Law provides for partial financing of Swiss teachers in foreign schools.

In such cases the initiative has to come from the local Swiss community, which must be prepared to take at least 50% of the cost on its own back. In the 1992/3 school year, 15 teachers in 10 different places were financed in this way. Since new Swiss schools are unlikely to be set up in the near future, mainly for financial reasons, Article 10 of the Law provides committed parents' associations with a logical alternative.

Heads of Swiss schools abroad are available to share their experience and know-


### Thank you, Pro Patria
