Switzerland at COP 17

Switzerland has sent a 31 person strong delegation to the 17th Conference of the Parties of the United Nations Framework Convention on Climate Change (COP 17) which took place from 28 November to 11 December 2011 in Durban.

The delegation was made up of members of the Swiss administration from different departments, as well as from business, civil society and science. It was led by Federal Councillor Doris Leuthard, Bruno Oberle, director of the Federal Office for the Environment, and Franz Perrez, Ambassador and Chief Negotiator.

In her speech, Federal Councillor Doris Leuthard emphasized the Swiss position. Switzerland is not

only ready to contribute to urgent action to combat climate change — it is already leading by example, e.g. through the introduction of a CO₂-tax on fossil fuels. In order to make a difference, however, all major emitters need to be included into a joint effort. This was the case when the current regime, the Kyoto Protocol, was designed: In those days, it was first and foremost the developed world that emitted, and hence most of the developed countries entered into commitments to reduce their emissions. Seven vears later, the world has changed, and growth and pollution patterns have changed significantly: Developed countries only contribute 45% to global emissions today. Some of the major emitters are located in the developing world. Change can only occur, if all major

emitters enter into a comprehensive regime that is legally binding, and that is based on the principle of "common but differentiated responsibilities and respective capabilities". This means that a regime has to take into account the level of development and possibilities of the different countries. In order to make this happen, Switzerland supports the establishment of the Green Climate Fund, which shall help countries with fewer capabilities to put the necessary national systems in place.

Both aims have been achieved: It has been decided at the eleventh hour in Durban that an international comprehensive regime with legal force will be negotiated by 2015 and put in place in 2020. Also, the Green Climate Fund will come into existence. It will hopefully soon be able to help poorer countries to mitigate the effects of climate change, and to adapt to rising average temperatures.

Two further elements must not be overlooked:
Business has begun to realize that green growth has enormous potential, and that saving energy (and hence polluting less) also is worth it in economic terms.

Furthermore, countries such as South Africa have realized this, and are putting efforts into coordinating respective policies to spur economic growth, to create jobs and to combat climate change. The recently released National Climate Change Response White Paper puts South Africa's pledge at the COP 15 2009 into practice, and shows ways and means of how the government is going to address the challenges. Neighbouring countries are about to do the same.

The activities of business, governments and the international conferences on climate change are intrinsically interlinked: If people are more aware, if business sees this as a right

way to go, and if national governments make it a priority, it is easier for heads of delegations at international conferences to commit to joint international action.

Although progress seems to be slow, the way points into the right direction. Moreover, progress can be sped up if the reduction of emissions is taken into account by each and every individual – through using energy efficient light bulbs, driving energy efficient cars, using energy efficient electric apparels, and – unfortunately - thinking twice about a flight to Switzerland, as avoiding it may help to combat climate change ...

The Election of 23 October 2011 and Auslandschweizer Performance

The general election in Switzerland took place on 23rd Octobber, and some 135'000 Auslandschweizer world-wide were registered to vote.

The overall result showed a weakening of the main established political parties such as the SVP, the FDP on the right, the CVP in the middle, and the SP and the GREENS on the left of the political spectrum. These losses were off-set, by gains in the new middle parties, namely the BDP and the GREEN LIBERALS.

75 Auslandschweizer world-wide stood for election. They did this in 6 individual candidatures on inland political party lists, and 69 candidates on 14 separate political party Auslandschweizer-lists in a total of 10 cantons. Regrettably none of these 75 Auslandschweizer managed to achieve election. This is not surprising, as with the present system, where Auslandschweizer votes are

spread across 26 possible cantons from which these Auslandschweizer come and, where they are registered. It is practically impossible for any Auslandschweizer candidate to garner enough votes to make any meaningful showing against inland candidates who are usually well known in their canton of election.

Your delegates have been saying this at Auslandschweizerrat meetings ever since the Auslandschweizer were eliqible to vote and to stand as candidates in 1992. If one gives the Auslandschweizer the vote, then it must be a vote that has a realistic chance of also being elected should one consent to being a candidate. Auslandschweizer are not merely to be regarded as party political list fillers, where the only significant benefit accrues to the party whose list is inserted into the ballot envelope.

Of the 75 Auslandschweizer candidates, 4 were from South Africa, all having been nominated by the International Division of the SVP, whose President is our own ASR Dekegate Rolf Schudel. Rolf has stood as a candidate at every general election during the past decade in a number of different cantons without success, and no-one knows better than he, what a hopelessly unfortunate "losing situation" faces a prospective Auslandschweizer candidate.

This contrasts with the lowest poll of 98 being for Erich Grübel from Lettland standing for the CVP in Canton Aargau, and the highest of 38'042 for Helen Freiemuth for the FDP in Canton Zürich.

For this reason your two delegates will be taking a strong stand in the next 2 years, as the ASR continues the dialogue with the parliamentary groups and the Department of Foreign Affairs (EDA) in Bern, regarding the proposed new Ausland-schweizergesetz, which is supposed to centralize, strengthen and suitably entrench rights and privil-eges, as well as obligations and duties for the Ausland-schweizer in the years ahead.

It is the considered opinion of your delegates, that it requires at least the formation of a 27th canton, called "Fünfte Schweiz" canton, where, as in all other cantons, there will be an election of 2 Ständeräte, and a number of Nationalräte based on the number of Swiss Abroad world-wide.

Only that way can the situation between the Inland - and Auslandschweizer be described as fair and equitable.
