## A geometric construction of the Conway potential function

## David Cimasoni


#### Abstract

We give a geometric construction of the multivariable Conway potential function for colored links. In the case of a single color, it is Kauffman's definition of the Conway polynomial in terms of a Seifert matrix.

## 1. Introduction

A colored link is an oriented link $L=L_{1} \cup \cdots \cup L_{\mu}$ in $S^{3}$ together with a surjective map $\sigma$ assigning to each component $L_{i}$ a color $\sigma(i) \in\{1, \ldots, n\}$. Two colored links $(L, \sigma)$ and ( $L^{\prime}, \sigma^{\prime}$ ) are isotopic if there exists an ambient isotopy from $L$ to $L^{\prime}$ preserving the color and orientation of each component.

Given a colored link $(L, \sigma)$ with exterior $X$, we have $\mathrm{H}_{1} X=\bigoplus_{i=1}^{\mu} \mathbb{Z} t_{i}$, where $t_{1}, \ldots, t_{\mu}$ denote the oriented meridians of $L$. The Hurewicz morphism $\pi_{1} X \longrightarrow$ $\mathrm{H}_{1} X$ composed with $\bigoplus_{i=1}^{\mu} \mathbb{Z} t_{i} \longrightarrow \bigoplus_{i=1}^{n} \mathbb{Z} t_{i}, \quad t_{i} \mapsto t_{\sigma(i)}$, determines a regular $\mathbb{Z}^{n}$-covering $\widehat{X}^{\sigma} \longrightarrow X$. The homology of $\widehat{X}^{\sigma}$ is endowed with a natural structure of module over $\Lambda_{n}=\mathbb{Z}\left[t_{1}, t_{1}^{-1}, \ldots, t_{n}, t_{n}^{-1}\right]$. The $\Lambda_{n}$-module $\mathrm{H}_{1} \widehat{X}^{\sigma}$ is called the Alexander module of $(L, \sigma)$ : it is an invariant of the colored link. The first elementary ideal of this module is principal; a generator is called the multivariable Alexander polynomial of $(L, \sigma)$. It is denoted by $\Delta_{L}^{\sigma}\left(t_{1}, \ldots, t_{n}\right)$. Note that $\Delta_{L}^{\sigma}$ is only defined modulo the units of $\Lambda_{n}$, that is, up to multiplication by $\pm t_{1}^{\nu_{1}} \cdots t_{n}^{\nu_{n}}$.

If $n=1, \Delta_{L}^{\sigma}(t)$ is nothing but the Alexander polynomial of the unordered oriented link $L$, as defined by James Alexander [1]. On the other hand, if $n=\mu$ and $\sigma=\mathrm{id}, \Delta_{L}^{\sigma}\left(t_{1}, \ldots, t_{\mu}\right)$ is denoted by $\Delta_{L}\left(t_{1}, \ldots, t_{\mu}\right)$ : it is the Alexander polynomial of the ordered oriented link $L$, defined by Ralph Fox [5]. Note that in general,

$$
\Delta_{L}^{\sigma}\left(t_{1}, \ldots, t_{n}\right) \doteq \Delta_{L}\left(t_{\sigma(1)}, \ldots, t_{\sigma(\mu)}\right)
$$

where $\doteq$ stands for the equality modulo the units of $\Lambda_{n}$.
In 1970, John Conway [2] introduced a new invariant of links called the poten-
tial function. Given a colored link $(L, \sigma)$, its potential function is a well-defined rational function $\nabla_{L}^{\sigma}\left(t_{1}, \ldots, t_{n}\right)$ which satisfies

$$
\nabla_{L}^{\sigma}\left(t_{1}, \ldots, t_{n}\right) \doteq \begin{cases}\frac{1}{t_{1}-t_{1}^{-1}} \Delta_{L}^{\sigma}\left(t_{1}^{2}\right) & \text { if } n=1 \\ \Delta_{L}^{\sigma}\left(t_{1}^{2}, \ldots, t_{n}^{2}\right) & \text { if } n>1\end{cases}
$$

Thus, this invariant is just the Alexander polynomial without the ambiguity concerning multiplication by units of $\Lambda_{n}$. This might seem a minor improvement. However, the potential function has a very remarkable new property: it can be computed directly from a link diagram using skein relations. For example, suppose that $\left(L_{+}, \sigma\right)\left(L_{-}, \sigma\right)$ and $\left(L_{0}, \sigma_{0}\right)$ are given by colored diagrams related by a single change as below, where $i$ stands for the color of the components.




Then, their potential functions satisfy the equality

$$
\nabla_{L_{+}}^{\sigma}-\nabla_{L_{-}}^{\sigma}=\left(t_{i}-t_{i}^{-1}\right) \cdot \nabla_{L_{0}}^{\sigma_{0}} .
$$

Similarly, if $L_{++}, L_{--}$and $L_{00}$ differ by the following local operation,



then we have the equality

$$
\nabla_{L_{++}}^{\sigma}+\nabla_{L_{--}}^{\sigma}=\left(t_{i} t_{j}+t_{i}^{-1} t_{j}^{-1}\right) \cdot \nabla_{L_{00}}^{\sigma} .
$$

Thus, Conway pointed out a preferred representative of the Alexander polynomial, and gave a very easy method for computing it. Unfortunately, his paper contains neither a precise definition of the potential function, nor a proof of its unicity. Quoting Conway: "We have not found a satisfactory explanation of these identities.(...) It seems plain that much work remains to be done in the field."

As a particular case of his potential function, Conway defined what he called the reduced polynomial $D_{L}(t)$ of a non-ordered link $L$ by

$$
D_{L}(t)=\left(t-t^{-1}\right) \cdot \nabla_{L}^{\sigma}(t),
$$

where $\sigma$ is the coloring map with a single color. This invariant was later called the Conway polynomial of $L$; we will use this terminology. Following from the properties of the general potential function, we have:
(i) $D_{L}$ is an invariant of the non-ordered oriented link $L$;
(ii) $D_{O}(t)=1$, where $O$ stands for the trivial knot;
(iii) $D_{L_{+}}(t)-D_{L_{-}}(t)=\left(t-t^{-1}\right) \cdot D_{L_{0}}(t)$, where $L_{+}, L_{-}$and $L_{0}$ are related by a single crossing change as below.

$L_{+}$

$L_{-}$

$L_{0}$

But again, the paper [2] contains no proof of the consistency of this system of axioms: there is no explicit model for $D_{L}$. On the other hand, it is very easy to check that if such a model exists, it is unique.

In 1981, Louis Kauffman [7] found a very simple geometric construction of the Conway polynomial $D_{L}(t)$, namely

$$
D_{L}(t)=\operatorname{det}\left(-t A+t^{-1} A^{T}\right)
$$

where $A$ is any Seifert matrix of the link $L$ and $A^{T}$ is the transpose of $A$. This result gave the requested model for $D_{L}$; it also provided the 'explanation' of the first skein relation.

Finally, in 1983, Richard Hartley [6] gave a definition of the multivariable potential function $\nabla_{L}^{\sigma}$. Quoting his introduction: "Kauffman showed how to define what may be called the reduced potential function of a link in terms of a Seifert matrix. This reduced potential function is an $L$-polynomial in one variable. However, the potential function is essentially a function of several variables, and I can see no way of generalising Kauffman's method to obtain the full potential function. Quite a different approach is therefore indicated." Indeed, Hartley's definition is obtained by normalizing the Alexander matrix given by the Wirtinger presentation via Fox free differential calculus: it is an algebraic construction, whose relation to Kauffman's model is not obvious at all.

In this paper, we give a geometric construction of the multivariable potential function which generalizes Kauffman's definition. It gives the relation between Hartley and Kauffman's models of the Conway polynomial, and provides an 'explanation' of Conway's skein formulas. It should be pointed out that the fundamental idea of this construction, that is, the use of 'C-complexes' for the computation of Alexander invariants of links, is due to Daryl Cooper [3, 4].

## 2. The potential function of a colored link

Let us denote by $\nabla_{L}$ the potential function of an ordered oriented link $L$ as defined by Hartley [6]; this corresponds to the case of a colored link ( $L, \sigma$ ) with $n=\mu$ and $\sigma=\mathrm{id}$. The potential function $\nabla_{L}^{\sigma}$ of an arbitrary colored link is given by

$$
\nabla_{L}^{\sigma}\left(t_{1}, \ldots, t_{n}\right)=\nabla_{L}\left(t_{\sigma(1)}, \ldots, t_{\sigma(\mu)}\right)
$$

The aim of this section is to present a geometric construction of $\nabla_{L}^{\sigma}$. This requires the use of C-complexes as defined by Cooper [3, 4].

Definition. A C-complex for a colored link $(L, \sigma)$ is a union $F=F_{1} \cup \cdots \cup F_{n}$ of compact oriented $P L$-embedded surfaces in $S^{3}$ which satisfies the following properties:
(i) $F$ is connected;
(ii) for all $i, \partial F_{i}$ is equal to the sublink of $L$ of color $i$;
(iii) for all $i \neq j, F_{i} \cap F_{j}$ is either empty, or a disjoint union of clasps (see Figure 1);
(iv) for all $i, j, k$ pairwise distinct, $F_{i} \cap F_{j} \cap F_{k}$ is empty.


Fig. 1. A positive clasp, and a negative clasp.
C-complexes are a natural generalization of Seifert surfaces; indeed, if $n=1$, a C-complex for $(L, \sigma)$ is simply a Seifert surface for $L$. Now, we need to define the Seifert forms associated to a C-complex. Let us fix a C-complex $F$ and a map $\epsilon:\{1, \ldots, n\} \rightarrow\{ \pm 1\}$. A 1-cycle $x$ in $F$ is called a loop if it has the following behaviour near a clasp (whenever it crosses one).


Given any element in $\mathrm{H}_{1} F$, it is possible to represent it by a loop; therefore, we can define a bilinear form $\alpha^{\epsilon}: \mathrm{H}_{1} F \times \mathrm{H}_{1} F \rightarrow \mathbb{Z}$ by

$$
\alpha^{\epsilon}([x],[y])=\ell k\left(x^{\epsilon}, y\right),
$$

where $\ell k$ denotes the linking number, $x$ is a loop, and $x^{\epsilon}$ is obtained by pushing $x$ off $F$ in the $\epsilon(i)$-normal direction off $F_{i}$ for all $i=1, \ldots, n$. In the neighborhood of a clasp in $F_{i} \cap F_{j}$, a loop $x$ can be pushed off $F$ in four different ways, which correspond to the four possible values of $(\epsilon(i), \epsilon(j))$. This is illustrated by the following cross-section of a clasp in $F_{i} \cap F_{j}$.


Of course, if $n=1, \alpha^{-}$is the usual Seifert form. Let us fix a basis of $\mathrm{H}_{1} F$ and denote by $A_{F}^{\epsilon}$ the matrix of $\alpha^{\epsilon}$. Note that for all $\epsilon$,

$$
A_{F}^{-\epsilon}=\left(A_{F}^{\epsilon}\right)^{T}
$$

We are now in position to state our main result.
Theorem. The Conway potential function of a colored link $(L, \sigma)$ is given by

$$
\nabla_{L}^{\sigma}\left(t_{1}, \ldots, t_{n}\right)=\operatorname{sgn}(F) \prod_{i=1}^{n}\left(t_{i}-t_{i}^{-1}\right)^{\chi\left(F \backslash F_{i}\right)-1} \operatorname{det}\left(-A_{F}\right),
$$

where $F$ is any $C$-complex for $(L, \sigma)$, and where
$-\operatorname{sgn}(F)$ is equal to the product of the signs of all the clasps in $F$ (see Figure 1);
$-A_{F}=\sum_{\epsilon} \epsilon(1) \cdots \epsilon(n) \cdot t_{1}^{\epsilon(1)} \cdots t_{n}^{\epsilon(n)} \cdot A_{F}^{\epsilon}$, the sum being on the $2^{n}$ maps $\epsilon:\{1, \ldots, n\} \rightarrow\{ \pm 1\}$.

Example 1. If $n=1, F$ is a Seifert surface for the $\operatorname{link} L$ and $A_{F}^{-}$is nothing but a usual Seifert matrix $A$. Since $A_{F}^{+}=A^{T}$, we have

$$
\nabla_{L}^{\sigma}(t)=\frac{1}{t-t^{-1}} \cdot \operatorname{det}\left(-t A^{T}+t^{-1} A\right)
$$

giving Kauffman's construction of the Conway polynomial

$$
D_{L}(t)=\left(t-t^{-1}\right) \cdot \nabla_{L}^{\sigma}(t)=\operatorname{det}\left(-t A+t^{-1} A^{T}\right)
$$

Example 2. If $n=2$, let us denote by $x, y$ the variables and by $F=F_{x} \cup F_{y}$ a C-complex for $(L, \sigma)$. Let us also note $A_{F}^{--}=A$ and $A_{F}^{-+}=B$. We then have the formula

$$
\begin{aligned}
\nabla_{L}^{\sigma}(x, y)= & \operatorname{sgn}(F)\left(x-x^{-1}\right)^{\chi\left(F_{y}\right)-1}\left(y-y^{-1}\right)^{\chi\left(F_{x}\right)-1} \times \\
& \times \operatorname{det}\left(-x y A^{T}+x y^{-1} B^{T}+x^{-1} y B-x^{-1} y^{-1} A\right) .
\end{aligned}
$$

Compare Cooper [4, Corollary 2.2].
Example 3. Consider the link $L=L_{1} \cup L_{2} \cup L_{3}$ with colors $\sigma(1)=\sigma(2)=x$ and $\sigma(3)=y$ given by the following diagram. We have two different ways to compute the potential function $\nabla_{L}^{\sigma}(x, y)$ using our construction. The first one is to consider a C-complex for the colored

link ( $L, \sigma$ ), and to compute $\nabla_{L}^{\sigma}(x, y)$ directly; the second one is to calculate $\nabla_{L}\left(t_{1}, t_{2}, t_{3}\right)$ using a C-complex for the ordered link $L$, and to use the equality $\nabla_{L}^{\sigma}(x, y)=\nabla_{L}(x, x, y)$. Here are C-complexes $F=F_{x} \cup F_{y}$ for ( $L, \sigma$ ) and $F^{\prime}=F_{1} \cup F_{2} \cup F_{3}$ for the ordered link $L$.


In the obvious basis of $\mathrm{H}_{1} F$, we have $A_{F}^{--}=A_{F}^{-+}=(-1)$; therefore, the theorem gives

$$
\nabla_{L}^{\sigma}(x, y)=\left(x-x^{-1}\right)^{0} \cdot\left(y-y^{-1}\right)^{-1} \cdot\left(x y-x^{-1} y-x y^{-1}+x^{-1} y^{-1}\right)=x-x^{-1}
$$

On the other hand, $F^{\prime}$ is contractible, giving

$$
\nabla_{L}\left(t_{1}, t_{2}, t_{3}\right)=\left(t_{1}-t_{1}^{-1}\right)^{0} \cdot\left(t_{2}-t_{2}^{-1}\right)^{1} \cdot\left(t_{3}-t_{3}^{-1}\right)^{0}=t_{2}-t_{2}^{-1}
$$

and we get the same result $\nabla_{L}^{\sigma}(x, y)=\nabla_{L}(x, x, y)=x-x^{-1}$.

## 3. Proof of the theorem

Let us recall very briefly Kauffman's argument [7]: given an oriented link $L$, he sets $\Omega_{L}(t)=\operatorname{det}\left(-t A+t^{-1} A^{T}\right)$, where $A$ is any Seifert surface for $L$. The first step is to check that $\Omega_{L}$ is an isotopy invariant of $L$. This is achieved using a well known result: two Seifert surfaces for ambient isotopic links can be obtained from each other by a finite number of ambient isotopies and handle attachments. We are left with the easy proof that $\Omega_{L}$ is unchanged by attaching a handle to $F$. Then, Kauffman proves that $\Omega_{L}$ satisfies the equality

$$
\Omega_{L_{+}}(t)-\Omega_{L_{-}}(t)=\left(t-t^{-1}\right) \cdot \Omega_{L_{0}}(t)
$$

where $L_{+}, L_{-}$and $L_{0}$ are related by a single crossing change as described in the introduction. This relation, along with the value of $\Omega$ for the trivial knot, determines $\Omega$ for any link. Since this relation was among the formulas announced by Conway for his polynomial $D$, and since $\Omega$ and $D$ have the same value on the trivial knot, they are the same invariant.

We will follow the same procedure for the general case. First, we define $\Omega_{L}^{\sigma}$ to be the right-hand side of the equality in the theorem. To show that $\Omega_{L}^{\sigma}$ is a well-defined isotopy invariant of colored links, we will generalize Cooper's Isotopy Lemma [4, Lemma 3.2]. A theorem of Murakami [9] states that the potential function $\nabla_{L}^{\sigma}$ is determined by several skein relations. Therefore, we will just need to check that $\Omega_{L}^{\sigma}$ satisfies these properties in order to have $\Omega=\nabla$.*

As a preliminary, let us define three transformations of C-complexes; the first two were introduced by Cooper. Given a C-complex $F$ and an arc $\alpha:[0,1] \rightarrow F_{i}$ with $\alpha^{-1}(\partial F)=\{0\}$, a push in $F_{i}$ along $\alpha$ is an embedding $p_{\alpha}: F \rightarrow F$ defined as follows: choose $\mathcal{N}_{1}, \mathcal{N}_{2}$ two closed regular neighborhoods of $\alpha$ in $F_{i}$ meeting $\partial F$ regularly such that $\mathcal{N}_{1} \subset \operatorname{int} \mathcal{N}_{2}$ and $\mathcal{N}_{2} \cap\left(\partial F \backslash \partial F_{i}\right)$ is empty. Then, $p_{\alpha}$ restricted to $F \backslash \operatorname{int} \mathcal{N}_{2}$ is the identity, and $p_{\alpha}$ maps $\mathcal{N}_{2}$ homeomorphically onto $\mathcal{N}_{2} \backslash \operatorname{int} \mathcal{N}_{1}$, as in Figure 2. Note that it is not allowed to push a boundary component through another one.

One can also transform a C-complex by adding a ribbon intersection, as described in the left part of Figure 3. The result is no longer a C-complex, but it can be transformed into one by pushing in $F_{i}$ along an arc through the ribbon intersection: this converts the ribbon intersection into a pair of clasps (see the right part of Figure 3). The lower part of this figure shows the same transformations as the upper part, with the Seifert surface $F_{i}$ represented as a disc.

Finally, the transformation illustrated in Figure 4 is called to pass through a clasp. Again, the lower part of this figure depicts the same transformation, with a disc representing the surface $F_{k}$. Note that these three transformations move the link $L$ only up to an ambient isotopy. Therefore, they can be understood as keeping $L=\partial F$ fixed.

We are now ready to start the proof of the theorem. Let $(L, \sigma)$ be a colored link in $S^{3}$.

Lemma 1. Let $F_{1}, \ldots, F_{n}$ be a collection of Seifert surfaces for the colored link $(L, \sigma)$ (i.e. for all $i, \partial F_{i}$ is equal to the sublink of $L$ of color $i$ ). Then, each $F_{i}$ can be isotoped keeping its boundary fixed to give a C-complex for ( $L, \sigma$ ).

Proof. Although it is an easy generalization of Cooper's [4, Lemma 3.1], it is worth giving the proof in some details. Let $F_{1}, \ldots, F_{n}$ be a collection of Seifert surfaces for $(L, \sigma)$. By isotopies, it may be assumed that they intersect transversally; therefore:

- for all $i \neq j, F_{i} \cap F_{j}$ is a finite union of intervals (clasps or ribbons) and circles (see Figure 5);
- for all $i, j, k$ pairwise distinct, $F_{i} \cap F_{j} \cap F_{k}$ is a finite number of points (called triple points);
- every quadruple intersection is empty.

By pushing along arcs, it is possible to remove every circle intersection as follows. First, push along an arc on $F_{1}$ through one of the outermost circles on $F_{1}$, avoiding the triple points: it will turn this circle intersection into a ribbon intersection. This method allows to remove every circle intersection on $F_{1}$. Use the same procedure for $F_{2}, \ldots, F_{n}$, turning every circle into a ribbon.

Now that all the intersections $F_{i} \cap F_{j}$ are finite unions of intervals, it is easy to remove all the triple points: pick an interval, number its possible triple points starting at one end and finishing at the other, and remove them in this order using the isotopy illustrated below.


By pushing along arcs, it is possible to transform all the ribbon intersections into pairs of clasps, as on the right part of Figure 3. We now have a union $F=F_{1} \cup \cdots \cup F_{n}$ which satisfies conditions (ii), (iii) and (iv) in the definition of a C-complex. By adding ribbon intersections and pushing along arcs (as in Figure 3), we can make $F$ connected.

Given $F$ a C-complex for ( $L, \sigma$ ), let us define

$$
\Omega_{F}\left(t_{1}, \ldots, t_{n}\right)=\operatorname{sgn}(F) \prod_{i=1}^{n}\left(t_{i}-t_{i}^{-1}\right)^{\chi\left(F \backslash F_{i}\right)-1} \operatorname{det}\left(-A_{F}\right)
$$

where $\operatorname{sgn}(F)$ is equal to the product of the signs of all the clasps in $F$, and where $A_{F}=\sum_{\epsilon} \epsilon(1) \cdots \epsilon(n) \cdot t_{1}^{\epsilon(1)} \cdots t_{n}^{\epsilon(n)} \cdot A_{F}^{\epsilon}$, the sum being on the $2^{n}$ different maps $\epsilon:\{1, \ldots, n\} \rightarrow\{ \pm 1\}$. To prove that $\Omega_{F}$ does not depend on the choice of $F$, we need two lemmas. The first one is well known (see e.g. [8, Theorem 8.2]).

Lemma 2. Two Seifert surfaces for a fixed link $L$ can be transformed into each other by a finite number of the following operations and their inverses:

- ambient isotopy keeping L fixed;
- addition of a handle.

The second is a generalization of Cooper's Isotopy Lemma [4, Lemma 3.2], which corresponds to the case $\mu=n=2$.

Lemma 3. Let $F=F_{1} \cup \cdots \cup F_{n}$ and $F^{\prime}=F_{1}^{\prime} \cup \cdots \cup F_{n}^{\prime}$ be two C-complexes for a fixed colored link $(L, \sigma)$. Suppose that, for all $i, F_{i}$ is ambient isotopic to $F_{i}^{\prime}$ keeping their boundary fixed. Then, $F$ and $F^{\prime}$ can be transformed into each other by a finite number of the following operations and their inverses:
(M0) ambient isotopy keeping L fixed;
(M1) addition of a ribbon intersection, followed by a push along an arc through this intersection;
(M2) pass through a clasp.

Proof. By [3, Lemma 5.2], there are other ambient isotopies $F_{i} \sim F_{i}^{\prime}\left(\right.$ rel $\left.\partial F_{i}\right)$ such that the surfaces $F_{1}, \ldots, F_{n}$ remain transverse throughout the isotopies except at a finite number of critical points, each of which occurs at a different time. Let us carry out these new isotopies one after the other: the result is an ambient isotopy $F \sim F^{\prime}($ rel $L)$ with finitely many critical points. Each critical point corresponds to a change in the singularity of $F$, that is, in the intersections $F_{i} \cap F_{j}$ and $F_{i} \cap F_{j} \cap F_{k}$ (the isotopies may be chosen avoiding quadruple intersections). We need to list all the possible transformations of these intersections, and convert them into combinations of the operations stated in the lemma.

Recall that the connected components of $F_{i} \cap F_{j}$ can be of the following three types: a clasp, a ribbon, or a circle (see Figure 5). The first step is to show that the isotopy may be chosen such that no circle intersection appears. The idea is to transform the isotopy by pushing along wandering arcs: a push in $F_{i}$ along a wandering arc is an embedding $p_{\alpha}: F_{i} \times I \rightarrow F_{i} \times I$ such that $p_{\alpha}$ restricted to $F_{i} \times\{t\}$ is a push along an arc $\alpha_{t}: I \rightarrow F_{i}$. A circle intersection in $F_{i} \cap F_{j}$ can be avoided as follows: push in $F_{i}$ along a wandering arc to the circle just before its appearance, keep the arc breaking the circle during the whole 'lifetime' of the circle, and remove the arc after the 'death' of the circle. Therefore, it may be assumed that all the intersections $F_{i} \cap F_{j}$ are clasps and ribbons.

Given any $i \neq j$, the number of clasps in $F_{i} \cap F_{j}$ is equal modulo 2 to the linking number $\ell k\left(\partial F_{i}, \partial F_{j}\right)$. Therefore, the parity of this number must be preserved. Considering critical points that are not triple points, we are left with the following possible transformations, where $*$ indicates the critical point.


Transformation $T 1$ is the addition of a ribbon intersection, while $T 2$ is a push along an arc through a ribbon intersection. Clearly, T3 can be converted into $T 2+T 4-T 2$, where $-T 2$ denotes the inverse of $T 2$. Finally, $T 4$ may be turned into $T 1$ and $T 2$ via a push in $F_{i}$ along a wandering arc.

Let us now consider critical points that are triple points, and denote by $T 5$ the move illustrated by the second arrow in Figure 4. Here is the 'movie' of $T 5$, where the asterisk denotes the critical points of 'birth' and 'death' of the triple point.


Of course, there are other transformations involving triple points; let us show that they can be converted into combinations of $T 1, T 2$ and $T 5$. By the beginning of the proof, we just need to convert such a move into combinations of $T 5$ and of transformations involving no triple points. Let us consider a transformation of a C-complex $F$ involving a triple point $x \in F_{1} \cap F_{2} \cap F_{3}$, and let us focus on the connected component $S$ of the singularity of $F$ containing $x$. By pushing along wandering arcs, it may be assumed that the only critical points on $S$ during the whole 'lifetime' of $x$ are the two critical points of 'birth' and 'death' of $x$. The idea is now to list all the possible configurations of $S$ (as in the middle of the 'movie' of $T 5$ ), and for every such $S$, to give all the different moves involving this $S$. Finally, we get seven possible configurations of $S$, and a dozen of (essentially) different moves. Then, it is an easy but tedious exercise to check that all these moves can be converted into combinations of $T 5$ and of transformations that do not involve triple points.

Hence, two C-complexes $F$ and $F^{\prime}$ as in the statement of the lemma can be transformed into each other by a finite number of the operations $M 0, T 1, T 2, T 5$ and their inverses. Since $F$ and $F^{\prime}$ are C-complexes, the transformations must start with $T 1$ or $-T 2$ and finish with $T 2$ or $-T 1$. Now, every combination of $\pm T 1, \pm T 2$ and $\pm T 5$ starting with $T 1$ or $-T 2$ and finishing with $T 2$ or $-T 1$ can be written as a combination of $\pm M 1= \pm(T 1+T 2)$ and $\pm M 2= \pm(-T 2+T 5+T 2)$. This settles the proof.

Lemma 4. Let $F$ and $F^{\prime}$ be two C-complexes for isotopic colored links $(L, \sigma)$ and ( $L^{\prime}, \sigma^{\prime}$ ). Then, $\Omega_{F}$ and $\Omega_{F^{\prime}}$ are equal.

Proof. Via an ambient isotopy (which does not change $\Omega_{F}$ ), we can assume that $\partial F=L=L^{\prime}=\partial F^{\prime}$. By Lemma 2, $F_{i}$ and $F_{i}^{\prime}$ are related by ambient isotopies (keeping $\partial F_{i}=\partial F_{i}^{\prime}$ fixed) and addition of handles. These handle additions are performed along arcs $\alpha$ embedded in $S^{3} \backslash F_{i}$; such an arc is isotopic (in $S^{3} \backslash F_{i}$ ) to an arc $\alpha^{\prime}$ embedded in $S^{3} \backslash F$. In other words, a handle attachment on $F_{i}$ can be performed avoiding $F \backslash F_{i}$. Let us call $M 3$ the addition of a handle on $F_{i}$ avoiding the rest of $F$. Now, for every ambient isotopy between $F_{i}$ and $F_{i}^{\prime}$, we can apply Lemma 3. Therefore, we just need to check that $\Omega_{F}$ remains unchanged if $F$ undergoes one of the moves $M 1, M 2$ or $M 3$.
(M1) Let $F^{\prime}$ be a C-complex obtained from $F$ via the move $M 1$. Clearly, $\mathrm{H}_{1} F^{\prime} \simeq$ $\mathbb{Z} \beta \oplus \mathbb{Z} \gamma \oplus \mathrm{H}_{1} F$, with $\beta$ and $\gamma$ as follows.

Among the new clasps created, one is positive and the other one is negative;

$$

(RVI) Let us suppose that $i=1, j=2$ and $k=3$. C-complexes $F(i)$ for $L(i)$ ( $i=1, \ldots, 6$ ) are obtained from a given C-complex $F$ for $L(7)$ as follows.

Clearly, $\mathrm{H}_{1} F(1) \simeq \mathrm{H}_{1} F(2) \simeq \mathrm{H}_{1} F(3) \simeq \mathrm{H}_{1} F(4) \simeq \mathbb{Z} \alpha \oplus \mathbb{Z} \beta \oplus \mathrm{H}_{1} F$, and $\mathrm{H}_{1} F(5) \simeq \mathbb{Z} \alpha \oplus \mathrm{H}_{1} F, \mathrm{H}_{1} F(6) \simeq \mathbb{Z} \beta \oplus \mathrm{H}_{1} F$. By the equalities

$$
\operatorname{sgn}(F(i))=\operatorname{sgn}(F) \quad \text { for all } i
$$

and

$$
\begin{aligned}
& \chi\left(F(1) \backslash F(1)_{i}\right)= \begin{cases}\chi\left(F \backslash F_{i}\right)-1 & \text { if } i=1,2 ; \\
\chi\left(F \backslash F_{3}\right) & \text { if } i=3 ; \\
\chi\left(F \backslash F_{i}\right)-2 & \text { if } i>3,\end{cases} \\
& \chi\left(F(2) \backslash F(2)_{i}\right)= \begin{cases}\chi\left(F \backslash F_{1}\right) & \text { if } i=1 ; \\
\chi\left(F \backslash F_{i}\right)-1 & \text { if } i=2,3 ; \\
\chi\left(F \backslash F_{i}\right)-2 & \text { if } i>3,\end{cases} \\
& \chi\left(F(3) \backslash F(3)_{i}\right)=\left\{\begin{array}{ll}
\chi\left(F \backslash F_{i}\right)-1 & \text { if } i=1,3 ; \\
\chi\left(F \backslash F_{2}\right) & \text { if } i=2 ; \\
\chi\left(F \backslash F_{i}\right)-2 & \text { if } i>3,
\end{array}=\chi\left(F(4) \backslash F(4)_{i}\right),\right.
\end{aligned}
$$

\end{aligned}
$$

we need to check the following equation, where $T_{i}$ denotes $\left(t_{i}-t_{i}^{-1}\right)$ and $T=$ $\prod_{i>3}\left(t_{i}-t_{i}^{-1}\right):$

$$
\begin{aligned}
& \left(t_{1}+t_{1}^{-1}\right)\left(\frac{\operatorname{det}\left(-A_{F(1)}\right)}{T_{1} T^{2}}-\left(t_{1} t_{2} t_{3}^{-1}-t_{1}^{-1} t_{2}^{-1} t_{3}\right) \frac{\operatorname{det}\left(-A_{F(6)}\right)}{T_{1} T}\right) \\
- & \left(t_{3}+t_{3}^{-1}\right)\left(\frac{\operatorname{det}\left(-A_{F(2)}\right)}{T_{3} T^{2}}-\left(t_{1}^{-1} t_{2} t_{3}-t_{1} t_{2}^{-1} t_{3}^{-1}\right) \frac{\operatorname{det}\left(-A_{F(5)}\right)}{T_{3} T}\right) \\
= & \left(t_{1}^{-1} t_{3}-t_{1} t_{3}^{-1}\right)\left(\frac{\operatorname{det}\left(-A_{F(3)}\right)+\operatorname{det}\left(-A_{F(4))}\right.}{T_{1} T_{3} T^{2}}+\left(t_{1}^{-1} t_{3}+t_{1} t_{3}^{-1}\right) \operatorname{det}\left(-A_{F}\right)\right)
\end{aligned}
$$

Without loss of generality, it may be assumed that $F$ has the following form near the place of the skein relation.


It is then easy to compute the matrices $A_{F(i)}$ :

$$
\begin{aligned}
& -A_{F(1)}=\beta\left(\begin{array}{ccc}

-T_{1} t_{2}^{-1} t_{3}^{-1} T & 0 & v_{\beta} T_{1} T \\
w_{\alpha} T_{3} T & w_{\beta} T_{1} T & A_{F}
\end{array}\right), \\
& -A_{F(2)}=\beta\left(\begin{array}{ccc}
\alpha & \beta \\
0 & -t_{1} t_{2} T_{3} T & v_{\alpha} T_{3} T \\
-t_{1}^{-1} t_{2}^{-1} T_{3} T & \left(t_{1}^{-1} t_{2} t_{3}-t_{1} t_{2}^{-1} t_{3}^{-1}\right) & v_{\beta} T_{1} T \\
w_{\alpha} T_{3} T & w_{\beta} T_{1} T & A_{F}
\end{array}\right), \\
& -A_{F(3)}=\beta\left(\begin{array}{ccc}
\alpha & \beta & \\
0 & 0 & v_{\alpha} T_{3} T \\
0 & 0 & v_{\beta} T_{1} T \\
w_{\alpha} T_{3} T & w_{\beta} T_{1} T & A_{F}
\end{array}\right), \\
& \alpha \quad \beta \\
& -A_{F(4)}=\begin{array}{c}
\alpha \\
\beta
\end{array}\left(\begin{array}{ccc}
0 & T_{1} t_{2} T_{3} T & v_{\alpha} T_{3} T \\
-T_{1} t_{2}^{-1} T_{3} T & 0 & v_{\beta} T_{1} T \\

\end{array}\right), \\
& \alpha \\
& -A_{F(5)}=\alpha\left(\begin{array}{cc}

The equality can then be checked by direct computation. This concludes Lemma 5 , and the theorem is proved.

## 4. Applications

In his fundamental paper [2], Conway states various properties of his potential function. We show now that these properties follow immediately from our construction.

Proposition 1. $\nabla_{L}^{\sigma}\left(t_{1}^{-1}, \ldots, t_{n}^{-1}\right)=(-1)^{\mu} \nabla_{L}^{\sigma}\left(t_{1}, \ldots, t_{n}\right)$.
Proof. By the theorem, we easily get $\nabla_{L}\left(t_{1}^{-1}, \ldots, t_{\mu}^{-1}\right)=(-1)^{\nu} \nabla_{L}\left(t_{1}, \ldots, t_{\mu}\right)$, with

$$
\nu=\sum_{i=1}^{n}\left(\chi\left(F \backslash F_{i}\right)-1\right)+n \cdot \operatorname{rk~H} \mathrm{H}_{1} F .
$$

For $i=1, \ldots, n$, let us denote by $\mu_{i}$ the number of components of $L$ with color $i$. Computing modulo 2, we have

$$
\begin{aligned}
\nu & \equiv \sum_{i=1}^{n} \chi\left(F \backslash F_{i}\right)+n \cdot\left(\text { rk } \mathrm{H}_{1} F+1\right) \\
& \equiv \sum_{i=1}^{n}(\chi(F)+\overbrace{\chi\left(F_{i}\right)}^{\equiv \mu_{i}}+\chi\left(F_{i} \cap\left(F \backslash F_{i}\right)\right))+n \cdot \chi(F) \\
& \equiv \sum_{i=1}^{n} \mu_{i}+\sum_{i=1}^{n} \chi\left(F_{i} \cap\left(F \backslash F_{i}\right)\right)=\mu+2 \cdot \#\{\text { clasps }\} \equiv \mu,
\end{aligned}
$$

and the proposition is proved.
Proposition 2. $\nabla_{L}^{\sigma}\left(-t_{1}, \ldots,-t_{n}\right)=(-1)^{\mu} \nabla_{L}^{\sigma}\left(t_{1}, \ldots, t_{n}\right)$.
Proof. Exactly as Proposition 1.
Proposition 3. Let $(L, \sigma)$ be a colored link with $\# \sigma^{-1}(1)=\mu_{1}$, and let $\left(L^{\prime}, \sigma\right)$ be the same link with the opposite orientation on the sublink of color 1 . Then, we have the equality

$$
\nabla_{L^{\prime}}^{\sigma}\left(t_{1}, \ldots, t_{n}\right)=(-1)^{\mu_{1}} \nabla_{L}^{\sigma}\left(t_{1}^{-1}, t_{2}, \ldots, t_{n}\right) .
$$

Proof. If $F=F_{1} \cup \cdots \cup F_{n}$ is a C-complex for $L$, a C-complex for $L^{\prime}$ is given by $F^{\prime}=\left(-F_{1}\right) \cup F_{2} \cup \cdots \cup F_{n}$. Since $\operatorname{sgn}\left(F^{\prime}\right)=(-1)^{\#\left\{\text { clasps of } F_{1}\right\}} \cdot \operatorname{sgn}(F)=$ $(-1)^{\chi\left(F_{1} \cap\left(F \backslash F_{1}\right)\right)} \cdot \operatorname{sgn}(F)$ and $A_{F^{\prime}}^{\epsilon}=A_{F}^{\epsilon^{\prime}}$ with $\epsilon^{\prime}(1)=-\epsilon(1)$ and $\epsilon^{\prime}(i)=\epsilon(i)$ for $i>1$, we have

$$
\nabla_{L^{\prime}}\left(t_{1}, \ldots, t_{\mu}\right)=(-1)^{\nu} \nabla_{L}\left(t_{1}^{-1}, t_{2}, \ldots, t_{\mu}\right)
$$

where

$$
\begin{aligned}
\nu & =\chi\left(F_{1} \cap\left(F \backslash F_{1}\right)\right)+\chi\left(F \backslash F_{1}\right)-1+\mathrm{rk} \mathrm{H}_{1} F \\
& \equiv \chi(F)-\chi\left(F \backslash F_{1}\right)+\chi\left(F_{1} \cap\left(F \backslash F_{1}\right)\right)=\chi\left(F_{1}\right) \equiv \mu_{1} .
\end{aligned}
$$

This settles the proof.
Corollary 1. $\nabla_{-L}^{\sigma}\left(t_{1}, \ldots, t_{n}\right)=(-1)^{\mu} \nabla_{L}^{\sigma}\left(t_{1}^{-1}, \ldots, t_{n}^{-1}\right)$.
Corollary 2. $\nabla_{-L}^{\sigma}=\nabla_{L}^{\sigma}$.
Proposition 4. $\nabla_{m(L)}^{\sigma}=(-1)^{\mu+1} \nabla_{L}^{\sigma}$, where $m(L)$ denotes the mirror image of $L$.

Proof. The mirror image $m(F)$ of a C-complex $F$ for $L$ provides a C-complex for $m(L)$. The sign of every clasp and of every linking number is changed, giving $A_{m(F)}^{\epsilon}=-A_{F}^{\epsilon}$ for all $\epsilon$. Hence

$$
\nabla_{m(L)}=(-1)^{\#\{\text { clasps of } F\}} \cdot(-1)^{\mathrm{rk} \mathrm{H}_{1} F} \cdot \nabla_{L}
$$

The equality $\chi(F)=\sum_{i=1}^{n} \chi\left(F_{i}\right)-\#\{$ clasps of $F\}$ yields

$$
\#\{\text { clasps of } F\}+\mathrm{rk} \mathrm{H}_{1} F=\mathrm{rk} \mathrm{H}_{1} F-\chi(F)+\sum_{i=1}^{\mu} \overbrace{\chi\left(F_{i}\right)}^{\equiv \mu_{i}} \equiv \mu+1,
$$

and the proposition is proved.
Let ( $L^{\prime}, \sigma^{\prime}$ ) and ( $L^{\prime \prime}, \sigma^{\prime \prime}$ ) be two colored links; let us suppose that two components $L_{i}^{\prime}$ of $L^{\prime}$ and $L_{j}^{\prime \prime}$ of $L^{\prime \prime}$ have the same color $\sigma^{\prime}(i)=\sigma^{\prime \prime}(j)=\alpha$. Then, there is a well-defined colored link given by the connected sum of $L^{\prime}$ and $L^{\prime \prime}$ along $L_{i}^{\prime}$ and $L_{j}^{\prime \prime}$; we will denote it by $\left(L^{\prime} \# L^{\prime \prime}, \sigma^{\prime} \# \sigma^{\prime \prime}\right)$. The following multiplicativity formula was also stated by Conway. As far as I know, there is no published proof.

Proposition 5. $\nabla_{L^{\prime} \# L^{\prime \prime}}^{\sigma^{\prime} \# \sigma^{\prime \prime}}=\nabla_{L^{\prime}}^{\sigma^{\prime}} \cdot \nabla_{L^{\prime \prime}}^{\sigma^{\prime \prime}} \cdot\left(t_{\alpha}-t_{\alpha}^{-1}\right)$.
Proof. Given C-complexes $F^{\prime}$ for ( $L^{\prime}, \sigma^{\prime}$ ) and $F^{\prime \prime}$ for ( $L^{\prime \prime}, \sigma^{\prime \prime}$ ), a C-complex for the connected sum ( $L^{\prime} \# L^{\prime \prime}, \sigma^{\prime} \# \sigma^{\prime \prime}$ ) is given by $F=F^{\prime} \# F^{\prime \prime}$. Clearly, $A_{F}^{\epsilon}=A_{F^{\prime}}^{\epsilon} \oplus A_{F^{\prime \prime}}^{\epsilon}$ for all $\epsilon$, giving

$$
A_{F}=\left(\prod_{j \neq \alpha}\left(t_{j}^{\prime \prime}-\left(t_{j}^{\prime \prime}\right)^{-1}\right) \cdot A_{F^{\prime}}\right) \oplus\left(\prod_{i \neq \alpha}\left(t_{i}^{\prime}-\left(t_{i}^{\prime}\right)^{-1}\right) \cdot A_{F^{\prime \prime}}\right)
$$

Since $\operatorname{sgn}(F)=\operatorname{sgn}\left(F^{\prime}\right) \cdot \operatorname{sgn}\left(F^{\prime \prime}\right)$ and

$$
\begin{aligned}
\chi\left(F \backslash F_{i}^{\prime}\right) & =\chi\left(F^{\prime} \backslash F_{i}^{\prime}\right)+\chi\left(F^{\prime \prime}\right)-1 \quad \forall i \neq \alpha, \\
\chi\left(F \backslash F_{j}^{\prime \prime}\right) & =\chi\left(F^{\prime}\right)+\chi\left(F^{\prime \prime} \backslash F_{j}^{\prime \prime}\right)-1 \quad \forall j \neq \alpha, \\
\chi\left(F \backslash F_{\alpha}\right) & =\chi\left(F^{\prime} \backslash F_{\alpha}^{\prime}\right)+\chi\left(F^{\prime \prime} \backslash F_{\alpha}^{\prime \prime}\right),
\end{aligned}
$$

we get the result.

For the sake of completeness, let us mention without proof two additional properties of Conway's potential function. The first one is another skein relation announced by Conway, that can be proved using our construction.

Proposition 6. $\nabla_{L_{1}}^{\sigma}+\nabla_{L_{2}}^{\sigma}=\nabla_{L_{3}}^{\sigma}+\nabla_{L_{4}}^{\sigma}$, where $L_{1}, L_{2}, L_{3}$ and $L_{4}$ are identical except within a ball where they are related as illustrated below.

The second one is the translation of the Torres formula [10, Theorem 3] from the Alexander polynomial to the Conway potential function. This formula can be recovered from our theorem, but the proof is a little tedious.

Proposition 7. $\nabla_{L}\left(1, t_{2}, \ldots, t_{\mu}\right)=\left(t_{2}^{\ell_{12}} \cdots t_{\mu}^{\ell_{1 \mu}}-t_{2}^{-\ell_{12}} \cdots t_{\mu}^{-\ell_{1 \mu}}\right) \cdot \nabla_{L \backslash L_{1}}\left(t_{2}, \ldots, t_{\mu}\right)$, where $\ell_{1 i}$ denotes the linking number $\ell k\left(L_{1}, L_{i}\right)$.
