#### RIFLE MASTER'S FINANCIAL REPORT 1991-1992

The report shows a balance as per 31 May 91 of \$2767.21, an income of \$1340.36 and expenditure of \$426.55 during the year, leaving a balance of \$3681.02 as per 31 May 92. The account at the Gewerbebank Baden stood at CHF2506.10. After deduction of tax and costs for medals totalling CHF1848.10 the balance as per 31 May 92 is CHF658.00.
