The answer to the Swiss Flag is:

The Swiss Flag as it looks today was introduced officially on December 12, 1889. The use of white crosses is much older though. The sign of the cross on red ground was first (since the 13th century) just periodically used along with the State or Cantonal flags (the Swiss Cantons being autonomous but joined together in the Swiss Confederation).

There are different theories about the origins of the cross, the most obvious one being that it is symbolically related to Christianity. The Cross represents the cross, Jesus was put on, the red colour represents his blood.

The red colour is an analogy to the red colour of blood.

The Swiss flag is square and each arm of the cross has to be of the same size and must be 1/6 longer than wide.
