General Business:

Club reports:

Christchurch: Unfortunately we have had very little news from the Christchurch Swiss Club, but it appears that they are struggling to form a committee. Mr Nobs advised that he would be visiting them in due course.

Hamilton: Herbert advised that their club was proud of the great number of participants in the medals competition, and their good muster of people travelling to Taranaki to compete in the Cowbell competition final. They are in the midst of six card evenings with average attendance 44. Jubilee will be held on 22 July and would like support from other clubs. Entertainment will be provided by the Swiss-Kiwi Yodellers and Holzhacker Band. September will have their fondue evening. Have regular walks. Good support of events. Herbert thanked his whole committee for their help.

Auckland: Fritz Scheidegger greeted everyone, and congratulated Taranaki on winning the Cowbell. Membership of the Auckland Swiss Club is currently 147. They have had good attendance at functions, and at the Christmas function, Santa came via helicopter. Last year they held their 1st August celebrations in the city as opposed to the Swiss Farm, which proved to be a pleasant change. On that day the Swiss flag was raised on the Harbour Bridge, an event that Fritz enjoyed. Their 50th jubilee is coming up. Due to recent vandalism they have installed cameras at the farm. Their long-standing treasurer Heinz Matysik has resigned his position but has remained on the committee. Fritz brought up the subject of indemnifying clubs against accident (re: OSH / ACC).
