### MINUTES OF THE 9<sup>th</sup> GENERAL MEETING OF THE INTERNA- TIONAL ASSOCIATION FOR DIALOGUE ANALYSIS

of the University of Göteborg, Stora  
Hörsalen (Large Auditorium).

The President reported on recent publi-  
cations.

He reported that the Proceedings of the  
Birmingham conference on *Working  
with Dialogue*, had appeared in 2000  
(Malcolm Coulthard, Janet Cotterill

and Frances Rock, eds., *Dialogue Analysis VII*, Tübingen: Niemeyer). He also announced that effective members (who had paid their membership fees) would also receive the first issue of IADA Forum, included in «*Studies in Communication Sciences / Studi di scienze della comunicazione*» (ISSN1424-4896). The journal is published by the University of Italian Switzerland (Università della Svizzera Italiana, Via Giuseppe Buffi 13, CH-6900 Lugano).

Our association has a regular section in the journal, called «IADA Forum», which will be sent free to all effective members. Its purpose is to help members keep informed on all recent activities (reports on conferences and round tables) and on essential information regarding themes chosen for future activities and how to participate.

The proceedings of the Bologna celebration of the 10 years of the association are also at the final editing stage and should be ready by the end of the year (Marina Bondi and Sorin Stati eds.).

## 2.

The President informed the Assembly that a workshop will be held in Utrecht in **2002** and asked Robert Maier to illustrate it.

The workshop will be held at Utrecht University in April 2002 (18<sup>th</sup>-20<sup>th</sup>) and will focus on *Dialogue Analysis in and around the multicultural classroom*. The idea was to bring together about 50/60 scholars discussing problems of interactions between children in multicultural schools and of the interaction between parents and teachers or between the school and the community: i.e., the multiplicity of dialogues taking place within and around the classroom in a multicultural context. A circular will be sent before the summer.

Organizers: Robert Maier ([r.maier@fss.uu.nl](mailto:r.maier@fss.uu.nl)) and Wolfgang Herrlitz ([wolfgang.herrlitz@let.uu.nl](mailto:wolfgang.herrlitz@let.uu.nl)), both at the University of Utrecht.

The President then invited Monika Dannerer to illustrate the proposal to host the next conference in Salzburg (Austria) in **2003**. The conference (**Dialogue Analysis IX**) would be organized by Anne Betten and Monika Dannerer of the Department of German Language and Literature of the University of Salzburg (Institut für Germanistik, Universität Salzburg, Akademiestrasse 20, A-5020 Salzburg, Austria; Tel.. ++43-662-8044-4357; Fax: ++43-662-8044-612).

Monika Dannerer presented the city and its University, highlighting the attractions of the place, as well as the city's long-standing experience in organising conferences. As for the dates, she said they proposed April 24<sup>th</sup> –26<sup>th</sup>. She also announced that there would be a general theme – Dialogue in Literature – with specific topic sessions to be announced later. The possibility of including discussion of dialogue in the media or other types of fictional dialogue as a sub-theme was also discussed. The organizers later suggested that the main theme could be announced as «Dialogue in Literature and the Media». As it is usual for our biennial conferences, however, it is hoped that most areas of dialogue analysis will be explored.

3.

Hundsnurscher proposed to introduce an Advisory Board in the structure of IADA, which will represent the countries where we have a significant number of members. The task of the new board, whose composition is to be decided by the President, is to coordinate the activities of members who are active within the respective countries in the time gap between conferences. Members of the advisory Board will have to promote new initiatives, as well as to contribute to the organisation of conferences.

After approving the outgoing secretariat's activity for 1997-1998, the members present proceeded to the election of the new secretariat by secret ballot. Marina Bondi, Malcolm Coulthard, Marcelo Dascal, Franz Hundsnurscher, Catherine Kerbrat-Orecchioni, Bernd Naumann, Eddo Rigotti, John Sinclair, Sorin Stati and Edda Weigand were elected unanimously.

5.

As for the publication of the Proceedings, Karin Aijmer and Jens Allwood offered to produce a volume of about 400 pages, containing all the plenaries and a selection of the papers that had been presented at the conference. They said that papers could be in any of the languages normally accepted in the series (English, German, French and Italian), although German and English in particular would be preferred by the publisher. They also tentatively suggested September 1<sup>st</sup> as a deadline for submitting contributions, but anticipated they would send instructions via email.

6.

The Secretary announced that the membership fee for 2001 is 60,000 Italian Lire (60 DM, 20 pounds).

The business of the day being concluded the chair closed the meeting.

## Notes for Contributors

*Contributions* in English, Italian, French or German must be submitted to the Executive Editor, Peter J. Schulz, Università della Svizzera italiana, Via Giuseppe Buffi 13, CH-6900 Lugano, Switzerland ([Peter.Schulz@lu.unisi.ch](mailto:Peter.Schulz@lu.unisi.ch)).

*Manuscripts* must be typed double-spaced *throughout* with a 5 cm margin (= 2 inch), including all quotes and the Notes and References sections, on one side of standard A4 or US letter size paper. All pages must be numbered. The first page contains title, the author's full names and affiliation and the mailing and email addresses. The second page should contain an abstract of about 150 words and up to 6 index keywords not contained in the title. In addition to the paper copy an electronic version of the manuscript must be submitted in either Macintosh or IBM-compatible format.

*Quotations* in the text should be enclosed in «double quotation marks». Use 'single quotes' only within double quotes. Words from other languages, and word intended to be especially emphasized, should be italicized (underlined).

*Footnotes* should be identified in the text by superscript numbers. Hyperlinks are acceptable in the text and footnotes.

*References* should be indicated in the text by the name of the author(s) and the year of publication according to the following examples: «... as mentioned by Jakobson (1972)»; «... as has been argued (Jakobson 1972: 34-38)». «Several authors have noted this trend (Smith 1970; Jones and Cook 1968; Dobbs et al. 1973)». The abbreviation "et al." should be used for references with three or more authors. For References to two or more papers by the same authors in the same year, the year should be followed by a letter (a, b, c, etc.).

*Reference section.* All works cited in the text must be listed alphabetically according to the first author in a Reference section at the end of the manuscript. References to books should include the place of publication and the publisher's name, and references to articles in journals should include volume and page numbers, as in the following examples:

AUSTIN, JOHN L. (1962). How to do things with words, Cambridge: Harvard U. Press.

KASHER, ASA (1991). On the pragmatic modules: A lecture. *Journal of Pragmatics* 16: 381-397.

KRIPKE, SAUL (1991). Speaker's reference and semantic reference. In: GARFIELD, J. & KITELEY, M. (eds.). Meaning and Truth. Essential Readings in Modern Semantics, New York: Paragon House.

*Tables* must be numbered consecutively with Roman numerals and titled, and must be referred to in the text. Each table should be typed, doublespaced, with due regard for the proportions of the printed page. Footnotes to tables should be identified by superscript letters and placed at the bottom of the page containing the table.

*Copyright.* Authors normally assign the copyright to the publisher. Authors who wish to own the copyright should place, at the bottom of their paper: «Copyright © Year, Name of author(s).» In this case the publisher owns the right to «store and serve» the paper in the Journal's archive.

*Galley-proofs* will be sent for correction to the corresponding author.

*Offprints.* 25 offprints of the papers will be sent free of charge to the corresponding author.
