## SCHWEIZERBUND (Swiss Club).

The Annual General Meeting of the above was held on January 31st. The keen interest which members take in the affairs of this Club was evident from the fact that over 100 members, amongst them many old acquaintances, were present, constituting a record attendance. The President, Mr. E. Fehr, opened proceedings. The satisfactory transactions of the year, recorded by the balance sheet, testify to the sound financial position of the Club.

The principal business of the evening was the election of the new Committee, and excitement ran unusually high during the election of a new President and a new Secretary, both these officials having resigned. The result of the voting confirmed the following appointments: President, Mr. F. Delaloye; Vice-President, Mr. Th. Nanzer; Joint Treasurers, Messrs. W. Schöneberger & W. Tschuy; Secretary, Mr. F. Burgin. The election for the post of Secretary was keenly contested. Elected as members of the Committee: Messrs. H. Berni, G. Freuler, M. Girard, E. Klingele, E. Lang, H. Ledermann, J. Martin, A. Ribaux, E. Rüttimann and L. Schilling.

An appeal made on behalf of the Gymnastic Section Schweizerbund for support from the younger Club members was strongly seconded.

The Committee wish to remind members of the Swiss Colony that they will always find a pleasant and hearty welcome at this old Swiss rendez-vous, the Schweizerbund.

## NOUV. SOCIÉTÉ HELVÉTIQUE

In conformity with one of the decisions of the Council we are now publishing for the first time extracts from the Secretary's monthly Report on the work of the Council.

1. In its ordinary meeting of 26th January and an extraordinary meeting of 9th February the Council discussed the "PROGRAMME D'ACTION" for 1921. It will be printed and sent to the members before the ANNUAL MEETING, which has been fixed for next FRIDAY, FEB. 18th, at 8 P.M. at STEINWAY HALL, 15-17, Lower Seymour Street, W.

2. The Special Commission which had been nominated for the purpose of

drawing up this "Programme d'Action" made a number of recommendations re the work of the Council and the Committee, and some proposals to increase the interest of the members and to make them participate in the work of the Society. The following were accepted by the Council:

SPECIAL COMMISSIONS to be nominated for the STUDY of various questions as they arise or for the EXECUTION of certain decisions of the Council or the General Meeting. Such Commissions to consist of five members at the minimum, of whom not more than two should be members of the Council. Special Commissions to be given proper hearing by the Council.

Lectures to be generally shorter; preference to be given to subjects which will lend themselves to discussion. Whenever possible, two speakers to deal with the same subject; the chief points of their statements to be mentioned on the convocation in order to provoke and facilitate discussion.

Social Evenings to be held from time to time.

New means of propaganda (membership cards, etc.) to be devised by the Propaganda and Finance Committees.

3. VISITORS FROM SWITZERLAND: All our members will receive an invitation and programme for Lieut. Pillichody's lecture of March 9th.

MONSIEUR R. DE TRAZ, Secrétaire des Suisses à l'étranger, will give a lecture at London University about 15th March, and be the guest of the Group on the 18th March.

4. As from time to time we get applications for the use of OUR ADDRESSES, the Council wishes to assure the members that these addresses are never given away and are only used for such purposes as are expressly approved by the Council.

5. Mr. G. GERBER, former Vice-President, is elected representative in Switzerland of the London Group, in lieu of Mr. R. Hofmann, who has resigned.

6. DR. A. LATT having resigned, the Group is on the look-out for another Secretary. Applications to be addressed to the President, Mr. Jean Baer, 6-8, Eastcheap, E.C.3.

7. Three APPEALS FOR FUNDS—the first from the Geneva Group in favour of the International Red Cross Committee, the second from the Central Committee in favour of the N.S.H. in Switzerland, the third from our new group at Essen (Germany)—are referred to the Finance Committee.

8. New members: 29 were received on the 26th of January, 10 on the 9th of February. Actual total about 650.
