LONDON FAIR AND MARKET.

This exhibition, organised by the International Trade Exhibitions, Ltd., was held at the Royal Agricultural Hall from July 3rd to 14th.

The fact that Switzerland was also represented there prompts us to give our readers a few details which they will find at once informative and interesting.

These details concern first of all the "Giant Omega" watch which was on view at the stand of the Omega Watch Co., whose factories are at Geneva and Bienne, and whose sole distributors are the Omega Watch Co. (England), Ltd., of 100, Hatton Garden, E.C.1. This fact, however, does not imply that Omega watches are solely obtainable through this source of supply; in point of fact, practically every Swiss house in London which deals in Swiss watches carries stock of "Omegas," consequently the term "sole distributors" is somewhat misleading to the uninitiated and needs this elucidation to prevent misapprehension.

We were furnished with the following technical particulars of the "Giant Omega," the size of which is equivalent to 230 lignes and measures 21½ inches in diameter.

A comparison with an ordinary pocket watch reveals the following remarkable differences:—

The giant watch was built throughout in the Omega factories and is a faithful enlargement, in every respect, of an "Omega" pocket watch, proving the perfect construction of the original. Being glass-covered front and back, the works and movement are perfectly visible, the only disadvantage is that it will not do for the ordinary waistcoat pocket and needs a very strong pair of hands for re-winding.

Although ladies are as prone to the attraction and charm of precious and true timekeepers as are the so-called sterner sex, we, nevertheless, venture to predict that some of them would have lingered much longer at another stand which was a little higher up the avenue of stalls, that of Messrs. Sigg, Ltd.; Frauenfeld. Many of our married male readers feel probably glad that this report appears somewhat belated (*which, by the way, is not our fault, for it seems to take an unreasonably long time to impart to the Swiss Colony in general the value of publicity*), as otherwise they might have had to loosen their purse strings considerably, had they been led to risk an entry into Sigg's Châlet in company with their good lady. The "Household Utensils" and other aluminium articles which emanate from Sigg's aluminium works at Frauenfeld, and which were on exhibition here, would have delighted the heart, and, incidentally, roused the desire for possession, in any domesticated Swiss "Husfraueli," and we are not sure whether we shall not still earn their gratitude by divulging the London Offices of Sigg, Ltd., which are at 469, Holloway Road, N.7. By doing so, we trust we shall escape the wrath of those husbands who may yet become victims, by seeking protection behind that little truism: "D'Liebi goht dur de Mage." —

Another exhibit in which there are also Swiss interests involved was the remarkable new "Bulle Clock" of the British Horo-Electric Ltd., of which firm our compatriot, Mr. H. Bingguely, is a director.

The merits claimed for this electro-magnetic clock are summed up as follows: "The 'Bulle Clock' needs no

winding, no cleaning, no repairs. It gives no trouble, takes ten seconds to start, goes accurately for ten years, and supersedes all systems." W.
