HOME NEWS

The 450th anniversary of the Battle of Murten (Morat) is being celebrated this week on the historic battle ground, both Federal and Cantonal authorities being present at the festivities. (Vide special article in another column.)

On account of the high-water level of the Rhine the lower parts of Schaffhausen are suffering from inundation, traffic on some of the streets having to be diverted.

The last chapter in a long-drawn-out controversy has just been closed by the decision of the Federal Tribunal in Lausanne, which upheld as just and fair an offer of Frs. 50,000 made by the Federal Council to the relatives of Private Ernst Oswald, of Sommeri (Thurgau), who, whilst guarding the frontier, was shot and seriously wounded by an Italian sentry in November, 1918. After protracted negotiations the Confederation obtained compensation from the Italian Government to the amount of Frs. 133,000, but unfortunately, before the amount was actually paid, the supposed beneficiary—and his mother who was depending on him—had already died. The relatives, i.e., eight brothers and sisters, put in a claim for the whole amount.

The Hôtel Montana in Montana (Valais) is to be acquired by the Confederation for the purpose of a military sanatorium in place of those recently closed at Leysin and Davos; the price is said to be just over half-a-million francs.

The cantonal hospital of Olten has benefitted to the amount of Frs. 50,000 under the will of the late Mr. Emilie Kaiser, of Grellingen, who died recently at Dornach (Solothurn).

Five people were seriously injured last Sunday at Basle when the local motor-cycle club held a race meeting. One of the competitors, Walter Widmer, of Liestal, was having a trial spin when all of a sudden the steering gear refused to act. Before he could stop the engine, he was thrown off his machine, which raced along for a short distance, knocking down four spectators, who, together with the cyclist, are now in the cantonal hospital.

Two cyclists, Messrs. Favre (50) and Hubler (46), who were walking at the side of their machines on the road from St. Blaise to Neuchâtel, were knocked down by a motorist, Mr. Reinhold, the son of a La Chaux-de-Fonds manufacturer. The former was killed on the spot, whilst the latter was taken in a precarious condition to the hospital. Pourtalès at Neuchâtel; the motorist has been placed under arrest.

THE GENEVA FRACAS.

At Tuesday's session of the Swiss Parliament M. Motta, Minister of Foreign Affairs, delivered a long statement as to the incidents which occurred recently in Geneva, particularly the Fascist fight with Genevese Socialists which took place on June 12th. The Italian Government's protest to the Swiss Government was confirmed by M. Motta, who told the House that he had received a visit from the Italian Minister at Berne, Signor Garbasso, who informed him that the Italian Government had decided that unless they could have the assurance of the Swiss Government that similar incidents would not be repeated, no further Italian delegations would be sent to Geneva to attend any of the League of Nations meetings, as it was impossible for them to fulfil their duties except in a peaceful atmosphere.

M. Motta, on his part, had explained to the Italian Minister that the Swiss Federal Council had no power to forbid Socialist meetings being held in Geneva, and that, in fact, the regrettable disturbance in question had been caused by Fascists, most of them Italians residing in Geneva, who had gone to a meeting of Genevese Socialists. M. Motta further informed Parliament that he had had a consultation with the Genevese authorities, who, according to the Swiss Cantonal law,

have home-rule regarding local bye-laws, and had impressed upon the President of the Republic and the Canton of Geneva that it would be necessary in future to be more vigilant and to take adequate measures to prevent such incidents, forbidding, if necessary, any public meetings during the League of Nations sessions at Geneva. Above all, added the Swiss Foreign Minister, it was incumbent upon officials of the League of Nations and the I.L.O. to abstain from taking part in public gatherings, especially in view of the fact that they enjoy diplomatic immunity. Moreover, such incidents not only affected the situation at Geneva as the seat of the League, but also Switzerland's relations with other countries.

These declarations of the Swiss Foreign Minister came as a bombshell to the Genevese population, who declare that they are no longer masters in their own canton, if public meetings are to be denied them during all the gatherings of the League or the I.L.O. held in Geneva, which are of almost constant occurrence. Public meetings are, indeed, the very life of the Genevese people, and to prohibit them would be to render their lives dull and dreary.

A NEW ALPINE HUT.

The neighbourhood of the Kistenpass, on the border between Claris and the Grisons, is the proposed site of a new Alpine hut. The exceptional beauty of the surrounding glaciers and rock formations should prove to tourists irresistible, all the more so as the spot is the centre for a number of fascinating climbs in the summer and exhilarating ski tours in the winter. The hut, which will accommodate about 16 people, is being constructed by the Akademischer Alpenklub in Basle, in the name of which Prof. Fritz Zschokke, of the Basle University, is circulating a pressing appeal for financial contributions. MORAT.

Depuis un certain temps, dans tous les cantons de la Suisse, on se réjouit pour assister à la manifestation patriotique du 450^{ème} anniversaire de la victoire de Morat. Tous les journaux ont annoncé déjà une nombreuse participation.

Avant les nombreux participants de cette fête du 22 juin, nous voulons visiter cette jolie ville, pour en redire les origines, et nous les précéderons à la manifestation du neuvième centenaire de la glorieuse victoire du 22 juin 1476.

Cependant, pas plus que les savants, nous ne saurions déterminer exactement l'époque de la fondation de cette antique cité. Il paraît que Dame Histoire ne connaît point cette date. Il n'y a rien d'étonnant... si ce n'est qu'ici du moins, la science confesse humblement son ignorance. Elle s'en console pourtant en s'accordant l'innocent plaisir de faire remonter cette date à la nuit des temps. La nuit des temps règne souvent pour certaines sciences. Cependant la situation de Morat, la fertilité de son terrain, la beauté de son climat, nous autorisent à croire que, bien longtemps avant l'ère chrétienne, les rives de son lac étaient habitées. D'ailleurs, il est certain qu'une voie romaine franchissait son territoire; mais cette voie qui reliait Aventicum (Avenches) à Solodurum (Soleure), fut plus d'une fois fatale à la gracieuse cité de Mur-altum, car, à plusieurs reprises, elle fraya un passage aux hordes barbares qui ravagèrent l'Empire romain au 4^{ème} siècle et plus tard, aux flots destructeurs des Sarazins qui envahirent Morat et Avenches. De là, nous viennent vraisemblablement les quelques traditions qui subsistent encore de nos jours à l'endroit de ces terribles conquérants. Les quelques monuments qui ont échappé aux dévastations des barbares, témoignent de la haute antiquité de Morat. Il nous reste entre autres, un certain nombre de vases, de monnaies, de médailles et autres objets de l'époque romaine; puis la mention de cette ville dans les actes du Concile d'Épogne au 6^{ème} siècle.

La ville de Morat venait de passer un demi siècle sous la houlette des Evêques de Lausanne (1079—1128) lorsqu'elle vit s'élever, dans son voisinage, une nouvelle cité qui devait l'éclipser bien vite pour la dominer plus tard; cette soeur cadette était Fribourg. Elle fut pour fondateur ce même Duc Berthold IV auquel est attribué la restauration de Morat. Depuis cette date reculée, l'histoire nous montre ces deux villes presque toujours associées dans la bonne et la mauvaise fortune. Nous les voyons partager des destinées communes et subir ensemble la domination successive des Ducs de Zähringen, des Comtes de Savoie, des Empereurs d'Allemagne, etc. et conquérir leur indépendance et leur autonomie en recevant le baptême du sang au même champ d'honneur.

Dans des circonstances diverses, Morat éprouva bien des vicissitudes. Au XII^{ème} siècle, c'est le roi de Germanie, Conrad le Sabique qui l'assiège et la détruit de fond en comble; en 1416, c'est un incendie qui la consume; à peine relevée des ruines, elle vit ses murailles s'ébrécher et se trouver sous le feu de l'artillerie du Comte de Romont. Mais des retours de fortune viennent chaque fois réparer et compenser ces malheurs; la victoire du lendemain fait bien vite oublier les dangers et la frayeur de la veille. Le Duc Berthold IV ne se contenta point de reconstruire la ville que Conrad avait détruite et de la munir de puissants remparts, il lui octroya de plus grandes franchises et de nombreux privilèges. Il lui accorda le droit de se choisir son premier magistrat; il étendit sa juridiction sur tout le lac et sur plusieurs localités environnantes et dégrava de toute redevance certains établissements. Après l'incendie de 1416, la ville obtint de son
