SWISS BUDGET.

Federal Councillor Musy, head of the Federal Finance Dept., speaking at the session of the National Council, stated, that never before, in the history of our country, Parliament has been faced with such a serious position of the Federal finances. He said, that the war, and the economic troubles, immediately after the war had seriously affected the Federal finances. The year 1933 has so far proved disastrous, and in comparison with more prosperous years, a deficit of over 100 million francs is to be expected. "The position of the Swiss Federal Railways," he said, "is viewed by the government with the gravest concern, as the entire debt reaches to-day the amount of over 3 milliard francs. In 1931 the Federal Railways registered a loss of 10 million francs, in 1932 the deficit reached 50 million francs and the loss during the current year is estimated to pass the during the current year is estimated to pass the

60 million mark.
"The Federal Council," he continued, "is convinced and wishes to make it clear, that there convinced and wishes to make it clear, that there could be only one monetary policy in Switzerland, namely the policy to maintain the Swiss franc unswervingly to gold parity." He went on to justify the Swiss Budgetary policy, which was to meet the deficit of 100 million francs by rigid economy and fresh taxation.

THE ZONE DISPUTE.

The French Government has agreed to Montreux being the Meeting place of the international commission to discuss outstanding items in the Zone dispute.

The Swiss Post Office authorities are nothing if not enterprising. They have introduced at least a dozen novel schemes in their service for the public during the past year, and their stock of bright ideas has not yet run down.

Beginning this week they started an experimental distribution of parcels from shops to their customers within a radius of about six miles.

For parcels of this nature the ordinary parcel post rate of payment has been reduced by 50 per cent.

The postmen will also collect any charges on The postmen will also collect any charges on parcels, and if several parcels are being sent to any one address on approbation, the postman motor driver will call back at the house for the unwanted goods and bring them back to the shop.

The new service, however, is only granted to shops who promise a minimum of five parcels daily, and who undertake to employ the post for the full delivery of all their parcels,

FLIGHT FROM DOLLAR.

FLIGHT FROM DOLLAR.

Some idea of the meaning of the words "flight from the dollar" may be gauged from what is taking place in Switzerland with regard to the American currency.

According to reliable statistics, the eight principal Swiss banks have been opening new accounts in Swiss francs for American clients at the rate of over 1,000 daily for some weeks past. There are also a host of smaller private Swiss banks in which the same process is taking place.

These accounts bear no interest, and a charge is made for conversion of bills, bookkeeping, etc., but, none the less American depositors prefer to rely on the stability of the Swiss franc rather than to risk the perils of depreciation at home.

ZURICH.

Dr. Wilhelm Meier has been appointed Responsible Editor of Schweizerische Handelszeitung — Swiss commercial daily published in Zurich.

The pilot, lieutenant Albert du Pasquier from Geneva, was burned badly, and is in a serious condition. The observer, lieutenant Bänziger, from Wolfhalden (Appenzell) was killed outright.

Dr. Klöti, town-president of Zurich has started an action for defamation of character, against Dr. Tobler, "Gauführer" of the "Nationale Front" in Zurich.

BERNE.

The well-known "Pension Iseltwald" on the lake of Brienz, was destroyed by fire.

Dr. H. Stadlin, General Manager of the "Banque Populaire" in Berne will retire at the end of this year. Dr. Stadlin was born in 1872 at Zug, and practised for several years as an advocate in his native town. In 1902 he entered the cantonal government, of which he was a member for 18 years (Finance Dept.). In 1911 he entered Parliament (National Council) and nine years later, accepted the post of General Manager of the "Banque Populaire Suisse," which he occupied for L3 years. M. G. Fleury, Manager of the Zurich Branch, M. E. Matter, Manager of the Moutier Branch, M. A. Gonzenbach, Manager of the Uster Branch and M. Hübscher, Sub-Manager of Berne Branch, are also retiring, having reached the age-limit. the age-limit.

LUCERNE.

National Councillor Jakob Müller has died suddenly, owing to heart failure. M. Müller was born in 1869 and has been a member of Parliament

SCHWYZ.

The 30 years old Willi Halbheer from Bauma (Ct. Zurich), was killed on the Haggenspitz (Kleiner Mythen), when climbing a dangerous part, he slipped and fell down from a considerable height.

GENEVA.

After the riots of November, 1932, the Geneva After the riots of November, 1932, the Geneva Government made two laws, the one restricting demonstrations in the streets, the other adding to the penal code articles making punishable the preparation of disorder and the use of violence. These laws were accepted by the Grand Council, but a referendum was asked on them, but they were rejected by the electorate by a small majority. majority.

The budget of the canton of Geneva for the year 1934 estimates a revenue of 38,934,905 frs., and expenditure 43,612,340 frs., there will therefore be a deficit of 4.677,435 frs.
