Thus we can proceed to any destination in Switzerland as in ordinary times, but furnished only with five pounds. There's the rub. Only those with relations or friends in Switzerland who will invite them free of charge can take advantage of this travel freedom within its strict limitations. Still quite a few of us might be in that lucky position.
