## HAZEL SCHMID. Lunch Hour Recital.

Hazel Schmid, the young Swiss soprano, who recently won the Guildhall School of Music and Drama Prize, and also a French Government scholarship to study interpretation of French classic songs under the direction of M. Pierre Bernac in Paris, gave a lunch hour recital on Thursday, May 23rd, at the lovely and re-built St. James's Church, Piccadilly, W.1.

The programme included three arias of Bach (with organ accompaniment) — "Stein der über all Schätze", "Seufzer, Tränen, Kummer, Not", and "Es ist vollbracht" — and Schubert's "Der Hirt auf dem Felsen" with clarinet obbligato (Leonard Setreight), as well as four Lieder by Hugo Wolf — "Schlafendes Jesus Kind", "Der Gärtner", "In der Frühe" and "Er ist's".

Her voice has delicious warmth and purity; she sang Bach's aria "Seufzer, Tränen, Kummer, Not" with much warmth and purity of tone. Both Schubert's "Der Hirt auf dem Felsen" and Hugo Wolf's "Er ist's" were delightfully rendered.

Hazel Schmid is plainly an artist of more than ordinary intelligence, and we feel sure that with intensified training and studies — especially as to diction — she will in time make a name for herself, and we are eagerly looking forward to hearing this young artist at some of the musical functions in the Colony.

Both her accompanists, Bruce Hylton Stewart (organ) and Michael Pilkington (piano), served her with unfailing discretion and discernment.
