RETIREMENT OF MR. J. KELLER.

Mr. J. Keller of "Horgen", 38 Northwick Avenue, Kenton, until recently chief accountant and secretary of Britannia Iron & Steel Works Ltd., Bedford, a subsidiary of the Georg Fischer Ltd., Schaffhausen, has just retired from his post, and we tender him our best wishes for a long and happy retirement.

On the completion of his schooling in his home town in Switzerland, he entered a three years apprenticeship in a Bank, and on its conclusion stayed for another year as a clerk. He then packed his bag and went to Paris, where he obtained a position in a Bank. After four years *séjour* in the *ville lumière* he came to this country in the spring of 1914, taking up a position with the Banca Commerciale Italiana.

With the outbreak of the 2nd world war in 1939, Mr. Keller, after having spent many years with this banking concern, owing to circumstances unfortunately became redundant. After some time, he however accepted a position as chief accountant and secretary at Brown's Hotel, Dover Street, W.1. This occupation came to an end after six years owing to the change of proprietorship, but he was able to enter the services of the Britannia Iron & Steel Works Ltd., Bedford, in the capacity of chief accountant and secretary.

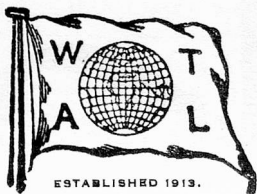
