Council's Annual Report for 1959/60.

The last Annual General Meeting was held on Tuesday, March 10th, 1959, at the Swiss Club, followed by a dinner. Since then, the following Open Meetings were organised by the Society:

- May 19th, 1959, at the Swiss Hostel for Girls: Social Meeting in honour of Mr. Alfred Stauffer, Editor of the "Swiss Observer", accompanied by his wife to celebrate his 30 years' association with this paper.
- June 23rd, 1959, at the Swiss Hostel for Girls: Conference by Mr. Felix Ansermoz, Secretary of the Swiss Embassy in London, on "A Hundred Years To-morrow (Henri Dunant at Solferino)".

It is our pleasant duty, once again, to give expression to our gratitude for the enlightened support accorded to the Society by the Swiss Ambassador, and to the invaluable assistance given by the Embassy's diplomatic and consular officers, several of whom excelled themselves as lecturers at our monthly meetings. Mr. A. F. Suter, Hon. Vice-President, and Mrs. Suter have attended almost all the Council Meetings and have given their support and advice. The "Swiss Observer", whose publisher and Editor honoured us officially with their presence in May, reported accurately and sympathetically on our activities, and we enjoyed also much friendly co-operation from Swissair and the Swiss National Tourist Miss Preiswerk and Miss Hagenbuch of the Swiss Hostel for Girls must be singled out for special praise for the excellence of their catering and their success in giving the atmosphere of a happy houseparty to our gatherings.

Journée des Suisses à l'Etranger.

This was held at the end of August at Lausanne and had as its main topics the new military tax law, the invalidity insurance scheme (supplementary to A.H.V.), and the already approved law dealing with assistance to war damage sufferers. Federal Councillor Wahlen spoke on emigration and rejuvenation of Swiss Colonies. The Society was represented by its President, who reported to the October Meeting, Mrs. Davidson, Messrs. A. F. Suter and Inebnit attended in their newly confirmed capacity as representatives of the Swiss Colony in Great Britain on the Auslandschweizer Kommission of the Nouvelle Société Helvétique.

Swiss Fortnight in October.

This great cultural manifestation, superbly organised from Switzerland, the Swiss Embassy and various Swiss Organisations in the United Kingdom, fully deserved the very considerable praise bestowed on it by a generally friendly English Press. The culminating events were the magnificent Ball at the Dorchester Hotel, and the Fête Suisse at the Albert Hall, both held in support of the British Pestalozzi Village Trust. Once again we were pleasantly aware of the many affinities between the United Kingdom and Switzerland.

Membership.
