AMBASSADOR'S MESSAGE

I hardly imagined, my dear compatriots, that my first Christmas message to you would also be my last.

As you will have heard, the world organisation GATT, whose headquarters are in Geneva, have expressed the wish to have a Swiss as their new Director. Their choice having fallen on me I have been asked by the Federal Council to accept a nomination which, if flattering for a small country like ours, entails a considerable amount of embarrassment for the nominee! But this is the prize to be paid for the Swiss policy of active neutrality.

My wife and I are bitterly disappointed to have to leave London with our mission barely under way. We feel on the other hand immensely grateful for all the friendly contacts which we have been able to establish with both the Swiss community and wide-ranging British circles during our all too brief stay in this country.

We are looking forward to spending Christmas in your midst and are wishing you and your families, pending a final farewell, a very happy New Year.
