TWO IMPORTANT EVENTS AT THE SWISS EMBASSY

The Swiss Ambassador and Madame Ernesto Thalmann gave a Reception on *1st December*, to mark the publication in English of Pastor Eberhard Busch's book "Karl Barth". The author and translator, the Rev. John Bowden and his wife were present and each gave a short address in reply to Monsieur Indermuehle, Cultural Counsellor's introduction. Pastor Busch was the great theologian's personal assistant, and the English translation is published by SCM Press Ltd.

The Archbishop of Canterbury, the Moderator of the General Assembly of the Church of Scotland and Mrs. Torrance, and the Apostolic Delegate, Archbishop Heim, were amongst the guests.

On *6th December*, Swiss journalists were invited to the Embassy to meet the Secretary-General of the Federal Political Department, Ambassador Weitnauer, who was in London for talks with the British Government. The Swiss Ambassador, Monsieur Thalmann, and the Press Secretary, Monsieur Ramseyer, were present.

Ambassador Weitnauer said that many countries, notably the United States, meant the EEC when they talked of Europe. Since Switzerland was not in the political organisation of the United Nations, nor in the Common Market, it was of great importance that bi-lateral discussions took place. He found them extremely helpful and again stressed that Great Britain showed great understanding and sympathy towards Switzerland.
