

Information for the Swiss abroad

At the end of 1980 and the beginning of the new year, a change has come in the service of information for the Swiss abroad. Their Secretariat in Berne was obliged to cease publication of the periodical «echo» with the December issue. This decision was not taken lightly. After all, this publication could look back over 61 full years and enjoyed great popularity with readers in Europe and overseas. The «echo», in three Swiss languages, with its richly illustrated articles, its carefully selected coloured covers and its topical summaries of internal problems and events, formed a welcome bridge to the home country; old and young subscribers affirmed this again and again. For us as publishers it was a valuable visiting card for the activities

and the existence of the Organization of the Swiss Abroad. At the same time, it represented serious involvement in the political life of the Swiss abroad and also a contribution to the presence of Switzerland abroad of which we were proud and – as we were assured from competent quarters again and again – had every reason to be so. Yet, the reasons which were the cause of ceasing publication of our monthly magazine were compelling:

Firstly, the increasing cost of production which could not be passed on to the rate of subscription due to the high exchange rate of the Swiss Franc, the deterioration of postal services near and far and the ever increasing administrative work

across the frontiers. Secondly, and above all, the concentration of forces.

For a number of years, we have had a quarterly publication which we have been able to produce in close co-operation with the Federal Department of Foreign Affairs which has handsomely supported it financially. This quarterly we are able to send to all Swiss nationals registered at Swiss Embassies and Consulates abroad. This publication is now well established. We shall endeavour to instil something of the spirit of the «echo» into its columns. This is the reason why we have changed the name and have now put it under the title «echo» which we shall keep for future issues. In view of the restricted space at our disposal, we shall have to make a specially attractive selection of our communications. On the other hand, we have the advantage that we reach all Swiss abroad with this publication four times a year, and amongst them also the loyal subscribers of the former «echo». This fact makes up for our loss and regret somewhat, and we are looking forward to the continuation of our contacts.

In addition it is pleasing for us to see that our quarterly provides a valuable supplement to the publications of their own in some of the Swiss communities abroad. We trust that this will remain the case also in the future.

We should like to take this opportunity of thanking sincerely the Service of the Swiss Abroad at the Federal Department of Foreign Affairs, led by Minister Maurice Jaccard, for their continued support. Our warm thanks go equally to the various personalities in Swiss communities abroad who look after the local and regional pages of the quarterly publication. *Marcel Ney*

«Terres de Fribourg»

A few Notes on the Drama


It is a kind of pageant representing the seven regions of the Canton. It has been created to celebrate in style the quincentenary of joining the Confederation. «A presentation of high artistic character, which includes folklore and recalls history, yet at the same time brings into view the present and even dares take a look into the future.» These were the main tasks put to the producer.

The Fribourgeois is an amateur; let us first look at singing: for every 1000 inhabitants there are 44 singers. He also loves play: his field is the comical aspect of his existence, possibly sometimes with a trace of the tragic. Comedy and tragedy, the main forms of occidental theatre; social and religious forms of expression. The «Terres de Fribourg» is a lyrical work with dramatic action, in the course of which the onlooker should recognize himself

and be able to laugh, to become pensive and possibly find comfort. But the Fribourgeois is diverse. His seven regions spread from the Pre-Alps over gentle hills to the lake. The daily light appears high above

and dies out down below in the plain and on the water. Each of these regions has a special voice and its own accent. And each wants to be heard it seems. Evidently, the Fribourgeois was told one day that «poor is only he who cannot be heard».

In these surroundings between the Alps and the lake, traversed by the Sarine, there is a village close to the linguistic frontier. Two opposing parts: Pierre and Michel. Pierre, Françoise's father, and Michel, her husband. Francoise embodies the town of Fribourg; Pierre, her father, the representative of the rural Cantons at the Diet of Stans, and Michel, her husband, the Cantonal President of Fribourg who endeavoured to have Fribourg in the Confederation. 1481 - the transition between two epochs and the basis for the creation of Frenchspeaking Switzerland in the European game.

1981 – transition in the world's spirit – but into what kind of era? In life as in the play, Pierre and Michel become antagonists. A plan defended by Pierre and still kept secret would lead to the sale of part of the village. From this, material gain would be made by some. The others feel themselves outside this transaction, although their lives, too, will be affected in the village by tomorrow.

This kind of drama within the play allows to keep awake the past and not only to display it. It permits presentation of customs and traditions (like «Bénichon», a kind of «Chilbi») with all their aura of yesterday. The object is to bring to light what has been hidden in darkness all too long. This drama about superstition and conspiracy is a play about darkness and light just like the black-and-white flag of Fribourg. Jean Winiger

Notes on the Staging

The object was to find the framework for a dramatic and lyrical play in which, at each performance, 2000 spectators and over 350 participants unite (actors, choristers, musicians and technicians). After a long search, the best possible location was found, the «Neigles Meadow» at the foot of the Cathedral, a charming idyllic place in the centre of the town – exactly what was needed.

The story takes place in a country village in the Canton of Fribourg. In

a pleasing manner, the stage leads to the Alps by way of a wide flight of stairs. This produces the free space necessary for the production. Plenty of room is needed so that the spirit (and the music) may unfold freely. The whole picture rests on reality without heaviness, in a familiar manner through which, I hope, everyone can recognize himself.

Three kinds of costumes are being used for the performances. Firstly, everyday clothes, personal clothes belonging to the players, figures of 1981. Secondly, the folkloristic costumes of the seven regions of the Canton, those of the choristers in the production. Thirdly, the historical costumes which have been specially designed and made for this event, those of men and women of 1481.

In front of the stage there are rows of seats going up in a circle, their profile following that of the stage representing the countryside. Thus all players and spectators are united in the action, gathered round the orchestra in the centre of the theatre, conducted by Pierre Kaelin who also composed the music. We may look forward with confidence to the gala evenings in June and July 1981. *Thierry Vernet*

velle Société Helvétique's Organization of the Swiss Abroad, the Executive Committee looks after the running business and prepares the work of the Commission. The theme includes not only education and training as such, but also problems which may arise in the various countries, as well as the difficulties which may arise on return to Switzerland. In this connection, the future of the Swiss schools abroad was discussed and their special tasks. The need was stressed that the Swiss communities abroad should get involved more closely in the running of these schools.

The main theme of the Assembly of the Swiss Abroad which is taking place in Solothurn from 21st to 23rd August, will be «New Forms of Swiss Emigration». This will again give an opportunity to consider the most important aspects of education and training as these are of special significance for shortterm emigrants.

Political rights of the Swiss abroad and the possibilities of a simplified manner of making use of them gave renewed cause for discussion. With the proposed more generous attitude towards foreigners resident in Switzerland, several objections held hitherto regarding postal voting from abroad might be reconsidered.

Regarding the question of citizenship of Swiss mothers and foreign fathers in the framework of equal rights between men and women, the Commission of the Swiss Abroad and its Executive Committee are awaiting with great interest the opinion of the Federal Council given to Parliament after the Initiative by the President of the Organization of the Swiss Abroad, former National Councillor Dr. Alfred Weber, Altdorf, had been accepted.

Without comment – excerpt from a letter written by a Swiss abroad

I would never have believed it... but it happened In 1965 my family and I had been living for some time in a Latin American country, where we were getting on very well. Then one day I heard about the Solidarity Fund for the Swiss Abroad. Yes, of course, I too was a Swiss abroad, but we had no intention whatsoever of returning home for good.

All the same, I thought to myself, I ought to join for the sake of solidarity. For a small sum, an annual payment of 100 francs, for example, I could become a member of that cooperative society and help a good cause at the same time. I, together with thousands of other Swiss abroad, would be building up a fund to assist less fortunate people trying to make a fresh start in Switzerland. Fantastic! And what about me? What do I stand to lose? Nothing, because after a given period I can withdraw my contributions, they will have earned interest and will even be exempt from withholding tax. I shall also be able to claim a lump-sum as compensation if I lose my livelihood as a result of political events in my second home. But, of course, that will never happen to us.

Fifteen years later – in 1980 – I am on the run. As the representative of a foreign group of companies I am in danger of being abducted and held to ransom. Our world is in ruins. My wife is in despair. The children are disconsolate because, of course, they speak the language of our host country better than «Schwyzerdütsch» and they don't want to leave their friends and their schools . . . Things look black, but we shall get over it; I am full of confidence, and I'm a realist. That is to say, I try to be!


But there is worse to come. On returning to the old country I start to look for a flat - but that doesn't work; first I must have a job. I don't mind where, it can be anywhere in Switzerland, I'm so flexible! And I'm not petty-minded, so I'm prepared to accept a subordinate position. But alas, at 52 the possibilities are limited. The parent company promises me a new post - as soon as something suitable becomes vacant; but that may take years. Up to today I have written between 120 and 150 applications - all in vain. What shall I do? I am desperate. In the middle of this tough period I hear from the Solidarity Fund of the Swiss Abroad, in Berne, that I am entitled to the lump-sum compensation. The contributions I have paid annually will also be refunded to me. This is wonderful after all the disappointment I have had since I got back. It gives me fresh courage.

Swiss abroad – we live in dangerous times. I would never have believed it, but it happened... Thanks to my solidarity since 1965 I have become a beneficiary in 1980. The Solidarity Fund is fantastic. Why don't you join – who knows, one day it may turn out to your advantage – or to that of one of your friends. I shall stay in it, out of solidarity with all of you, all over the world. Perhaps I shall be one of you again one day! *N.N.*

Excerpt

from an address given by Mr Frédéric Dubois, Director of the Federal Office for Cultural Affairs, at the Congress of the Swiss Abroad 1980

I have never before been called upon to deal with the question about which I am now going to speak to you: the Swiss schools abroad. Having only recently been appointed head of the Federal Office for Culture, I felt that your invitation gave me an occasion to look into the matter. Trying to make a virtue of necessity I approached it with an open mind, needless to say, but also in a spirit of constructive criticism.

The first discovery one makes is that it is possible for a Swiss diplomat to complete his career without ever coming into contact with a Swiss school abroad. Why? Well, because there are only 19 of them, eight being in Italy. The others are in Accra, Bangkok, Barcelona, Bogotà, Lima, Madrid, Mexico City, Rio de Janeiro, Santiago, Sao Paulo and Singapore.

You can see at a glance that history and tradition were responsible for the way they are scattered around the world, parallel to Switzerland's economic expansion last century and in the early 1900s. They were originally created in a pragmatic fashion, with no overall plan, and the Confederation was not involved. They were the work of pioneers, the result of vigorous personal initiative. They bear witness to the ability and the will of Swiss colonies established in countries which were (and to some extent still are) behind Switzerland in certain respects. Quite a number of those colonies played an important role in their host countries. Their schools were tolerated. They were - and they remain - strictly private institutions.

The principal motive for the creation of those schools was to give Swiss children abroad an education in keeping with the spirit, the methods and the aims of Swiss education and to make it easier for them to continue their studies if they returned to Switzerland. The wish that the children should have a neutral education from the religious standpoint was also a big factor. Furthermore, the school system in many of the countries concerned was far from fulfilling Swiss criteria and requirements, though this situation has improved. Finally, the colonies wanted, to some extent, to «keep themselves to themselves» and avoid integrating as much as possible. But there, too, things have changed a great deal. With the passage of

time the purpose of the schools has been broadened to include the following goals: to make it easier for Swiss firms to recruit staff for their branches abroad, to strengthen the relations of the Swiss abroad among themselves and to play a central role in their communities. By their permanent presence these institutions also represented, albeit modestly, a certain Swiss cultural presence in their host countries. Lastly, they gave Swiss teachers a chance to acquire a more profound knowledge of other nations and cultures while extending their linguistic and professional proficiency.

Aid from the Confederation was rather a long time coming and was not put on a legal basis until 1947. Its fundamental character, now that it is based on a federal Act, has not changed: the Confederation has only undertaken to subsidize the schools if certain conditions are fulfilled. However, the figures show clearly that we have here a special case. The 14.3 million francs allotted this year represent about two-thirds of the schools' income. A critical thereshold has thus been crossed, both materially and morally. The schools are now, without exception, dependent upon the Confederation, which is very undesirable because they are private institutions. It should also be noted that in many of the colonies financial resources and the willingness to make sacrifices for the sake of their schools have been diminishing appreciably for some time, especially since the Act came into force in 1976

Now that I have sketched in the outlines, I must give you the figures. Nothing reveals the true position more plainly.

As we have seen, there are, in all, 19 Swiss schools abroad. Ten of them educate their pupils up to the matriculation examination; as to the rest, the majority start with nursery school and end with the completion of secondary school studies.

The schools cater for 6,100 pupils, of whom 2,100 have Swiss nationality or a Swiss mother; there are 220 Swiss teachers.


Aid from the Confederation amounted to 14.3 million francs in 1979, that is to say, more than 2,500 francs per pupil. If we count only the Swiss children, who are the sole justification for these schools, that represents 7,000 francs per pupil.

Federal aid constitutes two-thirds of these schools' income, the rest coming, for the most part, from school fees. So the Confederation provides considerable support, as you see, but has no influence on the educational principles of the schools which, in a strict legal sense, remain private institutions. What I have just told you reveals a situation which poses not a few problems. May I outline it briefly for you:

Hitherto the Confederation's attitude to the schools has been apt to give rise to illusions. The Federal Council's «Message» of 21st December 1973 concerning the draft federal Act reflects this attitude: praise and generous promises were lavished on the schools but there was no critical consideration of their role. It is therefore not surprising that the Confederation's object in aiding these schools has not been made clear. Today the facts speak for themselves. People are questioning the reasons for sending children to the Swiss schools - reasons which should justify federal aid. Is it still appropriate to educate children in accordance with the socalled Swiss spirit when we know that they will never return to their country of origin? Would it not be more sensible for the second, third or fourth generation to integrate completely into their host country, as many Swiss families already do? Federal aid can only be justified today by the need to prepare children for transfer to schools in Switzerland.

In many countries it is no longer possible for private schools run by foreigners to lead a discreet existence secure from state intervention. Official controls have been strengthened. Will not the desired integration end by destroying our schools' raison d'être? Illegality, which is still frequent, cannot and must not be tolerated any longer. Some schools have structural difficulties. The concept behind the financing and management of the Swiss schools abroad was developed in the 19th century and is based on the existence of a strong colony with not only the financial means but also the necessary people for an institution run largely on an honorary basis. The Act makes the recognition of a school - and the continuance of that recognition - subject to clear conditions, whose effect is to accentuate the structural weaknesses of some schools. The Confederation's financial crisis does not permit of any increase in subsidies. This situation has forced the Federal Department of the Interior, and the Federal Council. to undertake a critical examination of the principles governing the support that is given. What mistakes have been made and what are the chances of attaining the objectives of federal aid?

The Act and the Ordinance clearly state the conditions on which a subsidy will be granted. In several cases these conditions are either not being fulfilled at all or are only partially fulfilled. The main reason is almost



always the same: the colonies concerned are no longer what they were. They are not vigorous enough to go on running their schools efficiently. What can still be achieved in these circumstances? The object of the Act, at least from today's standpoint, is to enable children of the Fifth Switzerland to continue their studies in our homeland. However, the statistics show a constant reduction in the number of pupils with this goal in view. Other aims, especially those covered by the vague phrase «cultural presence» (a task whose complexity should not be underestimated and for which we have other more appropriate - instruments), cannot conceal this state of affairs. On the other hand, we know that in many places there are large numbers of Swiss children who have no opportunity to attend a Swiss school. This is true of nearly all the French-speaking children, a matter to be taken seriously in view of our federal state's linguistic and cultural mixture. One can rightly speak of legal inequality in federal aid to the Swiss abroad.

The Federal Council shares the opinion of the Federal Department of the Interior that the situation definitely calls for therapy. In some cases surgery is required; in others, the treatment, if I can put it that way, will be medical, since the aim will be to eradicate the disease.

First of all, we must thoroughly examine those schools which no longer fulfil the legal conditions for recognition or which only survive thanks to the federal subsidies. I should like to stress the fact that this examination – which has already started – will be carried out in close collaboration with those responsible for the schools and other interested circles.

Right to vote of the Swiss abroad

As you know, the Swiss abroad entitled to vote, must be present in Switzerland in order to participate in federal voting and elections. Swiss abroad, be the exception to the rule!

History proves that the important decisions for the future and the rights of a people are always made by a minority.

With respect to the political rights of the Swiss abroad, or more precisely the exercise of those rights, we have reached a point where we need the help of every single Swiss man and woman abroad.

The regulation valid until today requires your personal presence in Switzerland to vote in elections and referendums. For your benefit, however, we would like you to have the right to exercise your political rights by correspondence.

Therefore:

1) You should register in large numbers with your official Swiss representative, even if you know that you will not be able to take advantage of this right, since, for example, you do not come to Switzerland very often. Your registration will show your interest clearly.

Aim of your registration:

If one notices that a large number of Swiss living abroad have registered in Switzerland, but only a small number actually come to Switzerland to vote, then the necessary measures will undoubtedly be enacted to change the present voting procedure.

2) Every Swiss man and woman abroad should fill in the questionnaire on page 27 of this magazine, and by doing so express his or her interest in the political life of **Switzerland.** Anyway, who is not interested?

By registering with your representative, you do the Swiss abroad as a whole a service, and do justice to the principles stated at the beginning of this text.

Citizenship Campaign

An endearing gesture

A campaign is under way that Swiss mothers married abroad to foreign fathers should be able to pass on Swiss citizenship to their children the same way as those mothers resident in Switzerland at the time of birth. In order to confirm their support, a group of Swiss women in Italy, led by Mrs. Margareth Bayard, Rome, decided to give a present to members of the Federal Parliament. It was a little cotton bag with some «Guetzli». nuts and tangerines and a drawing in each, made by the child of a Swiss mother and a foreign father.

With this symbolic gift, the children concerned wanted to demonstrate that they were willing to renounce their own Santa Claus bags in favour of the Swiss Members of Parliament and at the same time to draw attention to their own discrimination. The presentation under the cupola of the Federal Palace took place in co-operation with the Secretariat of the Swiss Abroad and was made by a real Santa Claus. He recited a specially written poem in Swiss-German: Samichlaus, du liebe Maa,

- in this dear Switzerland asks much too much.
- For mothers should have given birth at home,

and fathers should have lived there, too. To leave their work and homes for good would mean upheaval, trouble and cost too much.

Why should our treatment be unfair as if there were no good solution? A change of sentence only, and we're there, and we could Swiss become at once. On Swiss citizenship only we are bent – The goodies we leave for the Members of Parliament.

Take our bags quickly to the Chambers we trust,

from us «foreign» children in Switzerland be we must.

St. Nicolas, oh dear old man,

Please will you now do all you can.

Don't leave us. Love we do you as we may, Although from Berne we are all far away.

Just one thing now that still remains: To thank you warmly from our hearts. In unison we sing refrains so loud they sound in all Swiss parts:

From all foreign children and their mothers Swiss

Dankschoen, grazie, merci and many thanks it is.





Only one thing is still missing – **your application.**


