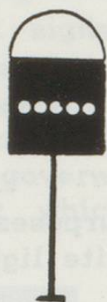

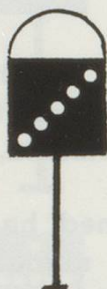

A diagonal line of white lights.

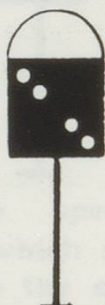
Audible signal - 2 short tones.

Audible signal - two long tones.
