POSTMARK CORNER

A large number of the smaller railways in Switzerland have operated mail services. Some have run travelling railway post offices but many more have offered a supplement to the normal post office services. It has often been possible to post letters at the local railway station when other services have been closed. So not only have packages and parcels been cancelled with railway postmarks but letters as well. Enthusiasts have been aware of this for some time and some fine collections built up. My own modest accumulation contains a variety of sizes and types. Many are rectangular but the one illustrated for the MThB, Mittel-Thurgau-Bahn is a more unusual circular design and issued at Kreuzlingen-Oberdorf station. However I have a query. Where is this station? It does not appear in any of my lists. Can readers help?

RENEWALS 2000 - Dave Howsam

The renewal form for 2000 subscriptions is included with this issue. All renewals should be forwarded directly to the membership secretary. Members in the USA, Australia and New Zealand will still be able to pay with an appropriate dollar cheque but this must be included with the renewal form and forwarded to the membership secretary. In addition, overseas members only, may pay by credit card, as a twelve month trial, details are on the appropriate renewal forms. It is possible for all overseas members to pay in sterling, but please note, this must be by cheque or draft payable in the UK and drawn on a UK bank. Subscriptions for UK subscriptions are now £11 after remaining at the previous level for a number of years. Overseas subscriptions are as last year, when they too were increased by £1. Each renewal form has the appropriate subscription rate on it.

Please note that a small stamped unaddressed envelope would be appreciated, from UK members only for the return of membership cards.

As the number of renewals is ever increasing (1034 members so far) - excellent news, exceeding our highest ever membership - it would be most helpful if no other correspondence requiring a reply is included. However it is one of the more pleasant aspects of the office to receive comments and updates on your visits etc.

The aim is to give a speedy and efficient service and members should know their renewal has been received and processed by the return of their membership card and the cashing of their cheque.
