### 2003 RENEWAL

The renewal form for all members for 2003 subscriptions is included with this issue.



All completed renewals should be forwarded directly to the Membership Secretary. Subscriptions for 2003 have all been held at last year's level. It is possible for members to pay for two years' subscription and this would save postage for you, slightly reduce any credit card surcharge as well as making a saving if subs are increased in the second year! USA members may still forward a US dollar cheque but payment for all other members must be in sterling, whether by credit card or by cheque or draft drawn on a UK bank and payable in the UK. Remember any credit card payment shows up as German Railway Society. Each renewal form has the appropriate subscription rate on it.

All members receive a renewal form with *Swiss Express*. If you have pre paid for 2003 please ignore it. A list of pre paid subscriptions will be no longer printed, but all such members should receive their 2003 membership card by mid December 2002.

At last! Please note that an SAE is not required this year and the inclusion of one will only slow down the process of renewal.

The aim is to give a speedy and efficient service and members should know their renewal has been received and processed by the return of their membership card and the encashment of their cheque. Forms are processed, usually, on the day of receipt. If you have not received your membership card within two weeks (for UK) you should contact me. Once again, members in the USA should send their renewal by ordinary airmail, as it has proved very reliable.

The number of subscriptions for 2002 is 1108 (end September), up already on last year although percentage renewal rate is slightly down.

I shall be present at the Mirfield exhibition on December 14th 2002 where members may renew and receive their new membership card.
